## 1. PURPOSE

1.1 To explore opportunities to mitigate issues relating to Statute Barred rates and Māori freehold land, and that those opportunities be actioned by the Economic Development and Engagement Manager.

## RECOMMENDATION

The Economic Development and Engagement Manager RECOMMENDS that the Committee receive this report and consider opportunities to mitigate issues relating to Statute Barred rates and Māori freehold land.

## **EXECUTIVE SUMMARY**

Council at its meeting on 20 June 2017 resolved to refer the matter of statute-barred rates to the Māori Standing Committee to explore opportunities to mitigate issues relating to Māori freehold land, and that those opportunities be actioned by the Economic Development and Engagement Manager.

Statute-barred rates are rates that have been levied six or more years before, and where no legal action has been taken for recovery. When rates on General or Māori land have not been paid, they becomes 'Statute Barred'.

## 2. BACKGROUND

Pursuant to section 65 of the Local Government (Rating) Act 2002, any action to recover unpaid rates must not be commenced in a court of competent jurisdiction later than six years after:

(a) The date on which rates become due if the local authority required the rates to be paid in one payment in a financial year; or

(b) The date on which the last payment became due if the local authority required the rates to be paid in a number of payments in a financial year.

- 2.1 Statute barred rates arrears for the year ending 30 June 2010 are \$293,306.25.
- 2.2 95.21% of statute-barred rates arrears are rates arrears on Māori freehold land. Ownership structures unique to Māori freehold land prohibit effective collection of rates assessed; rates arrears for Māori freehold land are often unrecoverable.

- 2.3 This issue was also discussed at the 27 June 2017 Economic Development Committee and the Chair of the Te Mātārae o Te Wairoa Trust noted that the Trust's Māori Land Development project aligned well with Council's wish to address the issue of statutebarred rates. The Trust requested support for a Māori Land Development Project Manager which could support Council's wish to reduce the quantum of statute-barred rates as well as looking at ways of supporting Māori land owners to make their land more productive.
- 2.4 The Economic Development Committee have recommended that the CEO identify savings in the current operational budget for the purpose of allocating funds to Te Mātārae o Te Wairoa Trust with the objective of reducing the quantum of statute-barred rates.

## 3. OPTIONS

- 3.1 The option identified is for the Māori Standing Committee to:
  - a. discuss and consider opportunities to mitigate the issues of Māori freehold land and statute-barred rates and refer to the Economic Development and Engagement Manager to action.

## What are the key benefits?

3.2 Reducing the quantum of statute-barred rates will see opportunities for Māori freehold land to become more productive, ensuring that the land parcels noted in statut-barred rates are correct and if errors are found, than those errors are corrected and/or the relevant information is updated.

## What is the cost?

3.3 This work will be covered in existing budgets.

## What is the saving?

3.4 The intent is to reduce the overall quantum of statute-barred rates.

## Who has been consulted?

3.5 Tangata whenua are a significant community that needs to be involved given that over 95% of land noted in statute-barred rates is Māori freehold land, hence why this has been referred from Council to the Māori Standing Committee.

## Maori Standing Committee

3.6 The Māori Standing Committee is well aware of this issue as it is an historic matter. Council has now referred this matter to the Māori Standing Committee to consider and address. A report will be prepared for Council with recommendations.

#### 1. PURPOSE

1.1 This report provides information for the Economic Development Committee on Council and community activities. No decisions are required by the Economic Development Committee at this stage.

#### RECOMMENDATION

*The Economic Development & Engagement Manager RECOMMENDS that the Economic Development Committee receive the report.* 

#### 2. JMP CONSULTING BUSINESS WORKSHOPS

Te Puni Kokiri has funded JMP Consulting to undertake a series of business workshops across the district. Particularly targeted at Māori business development, JMP Consulting, lead by Wairoa local Jody Hamilton, are currently undertaking business fundamentals workshops, business clinics and tailored coaching across the Wairoa District. JMP Consulting are working with a range of start-up and existing businesses including those in tourism, health and wellbeing, hospitality, beauty, retail, consultancy services, food and beverage, aquaculture, environmental services, horticulture, agriculture, arts and culture, hydro, security and accommodation. To date workshops and clinics have been held at Nūhaka, Māhia and Wairoa township with a total of approximately 30 business owners taking up the opportunity to participate in the series of workshops and clinics. This work will be completed by 30 June 2017, however there is support for ongoing delivery which will be explored with Te Puni Kokiri.

Jody and her team have seen an incredible amount of innovation and commitment in the business ideas across the district and look forward to be able to continue to work with these whanau enterprises on their business development journey.

#### 3. ROCKET LAB TEST LAUNCH (1)

Rocket Lab's first test launch was accomplished on Thursday, 25th of May. High level of local, regional and national media attention throughout the week May 22-25. Blucks Pit in Nuhaka was established as a viewing area and was well patronised. Of particular interest was 40 vehicles and approximately 70 individuals were counted at Blucks Pit viewing area on the 23rd of May. Inclement weather meant following days were less patronised. Visitors from Auckland, Wellington, Napier, Tauranga and locals were recorded at Blucks Pit. There was also a report of two (2) tour buses (approx 50 seater each) stopping at the Mahia Beach Cafe, the buses did not stop at Blucks Pit and the Wairoa District Council notes that Blucks Pit is not

designed for tour buses (access and turning bay). If Blucks Pit is to become a semi-permanent viewing area, additional financial support is required to further improve Blucks Pit for visitors (i.e. tour/charter bus access). Given that the Wairoa District Counil agreed not to actively promote the test launch phase, visitor numbers during the week 23-25 May suggest visitor numbers are likely to increase. There is a need to organise a community meeting in Nūhaka to inform the local community of any developments going forward and to keep the local community informed and involved. The Wairoa District Council will continue to work with local operators to capitalise on the increase number of visitors in time for commercial launch phase. Wairoa Airport also received three (3) charter planes with Rocket Lab staff. The Wairoa District Council will seek to have the Wairoa Airport and the work related to its upgrades (as a viable regional transport option and asset) added as an action item onto Matariki – the Hawke's Bay Regional Economic Development Strategy to encourage central government support to improve transport infrastructure.

#### 4. UFB2 ROLLOUT

Wairoa has been re-prioritised for the Government's Ultrafast Broadband Extension (UFB2) rollout. Eighteen towns will have their UFB builds fast-tracked to be complete by the end of 2020. These are towns in Northland, Bay of Plenty, Gisborne, Hawke's Bay, Manawatu-Whanganui and the West Coast. Work in Wairoa was initially scheduled to begin in July 2021, which would have meant a three year wait. Following that announcement by Chorus, his Worship the Mayor lobbied both Chorus and Crown Fibre Holdings to have Wairoa reprioritised recognising the district's demographic profile was ample justification for the community to be elevated on the list. Mayor Craig Little has welcomed the announcement by Chorus to have Wairoa re-prioritised, saying high-speed internet access is an essential component in making necessary advancements for our region in a new age of technology and economic development. *"Economic development is a matter of priority in the Wairoa district, and thanks to this announcement, we can now take the next step into the 'new economy'"*. UFB2 rollout in Wairoa is set to begin next year (June 2018) and is scheduled to be completed in May 2019.

#### 5. SOCIAL INCLUSION STRATEGY

Work from throughout the region looking at social inclusion strategies continues with the intent to have this body of work intertwined and aligned within Matariki – The Hawke's Bay Regional Economic Development Strategy. Good economic development inevitably means good social inclusion outcomes for the region. A regional group has been established to set out the social inclusion outcomes and it is intended that this group will meet seek to meet with and consult with the Wairoa District Council. Tentative date will be at the Council Forum scheduled for July 11<sup>th</sup>.

Work continues to install boundary and other signage. These should be installed week beginning 26<sup>th</sup> of June. They include the Northern and Southern Boundary signs, a new sign for Blacks Beach and a new sign for War Memorial Park. The Wairoa District Council is currently developing a signage strategy for the district so that a comprehensive and cohesive approach to signage is developed and implemented.

- Why is a signage strategy needed:
  - Creation of bilingual signage (where appropriate).
  - o Signage plays a big role in tourism as way-finding and storytelling for tourism.
  - o Signage plays a significant role in conveying community identity.

There is a desire to implement new signage as a result of the above drivers. There is a risk that implementation of signage without a coherent strategy could result in ad hoc, incohesive sign design and placement.

What the Signage Strategy could potentially cover

- Identify the signage types covered by the strategy (road, parks and reserves, walkway, street, community facility). Presumably Council controlled signage rather than private signage?
- Identification of relationships with other strategies (existing parks or tourism strategies).
- Themes and objectives sought by the various types of signage (i.e what is the message).
- List of all signage in the district (Council controlled signage only).
- Guidelines for the placement, design and content, legal requirements.
- Potentially determining where signage will be located or location selection criteria.
- Programme and priorities for implementation (potentially including costings).
- The process/steps before decision to install signage. (i.e decision flow chart consistency with strategy, appropriate translation into te reo).

The Signage Strategy will be presented to Council for approval once developed.

#### Wairoa District Council ED committee meeting- June update

#### 1) Maori Land Development

This project is rapidly gathering momentum and progress is being hampered because of need for a dedicated Project Manager. The Trust is seeking funding support for this position. The Trust has been in conversations with Shayne Walker (REDS) and he stressed that ED projects need to encompass social, cultural and environmental aspects as well to ensure 'social inclusion' element of REDS is addressed. The Maori Land Development work the Trust has been working in involves all these aspects.

#### Horticultural opportunities.

Seeka (BoP) have visited Wairoa to review the horticultural potential of the district. They believe the potential is significant for kiwifruit and avocados and in fact too big for Seeka alone to manage. Seeka have subsequently progressed the opportunity with central government (NZTE) re possibility of setting up a PGP.

As a result, the Trust focus has extended to 'Marae Sustainability' with Trustee Richard Allen contributing at meetings held with the Iwitea Marae committee looking at a 20 year plan for Iwitea Marae as a pilot exercise. The model will be able to be utilised for any of the other Marae's in the district with similar resources. There are huge opportunities for Maori owned land to be developed in conjunction with local Marae, with financial returns and social, environmental and cultural benefits.

Additionally, Cedenco are seeking 800 hectares in Wairoa for planting. It is important to ensure the current land assets aren't undervalued as they have clearly identified Wairoa as a significant horticultural opportunity.

#### Fresh water koura opportunities.

Koura – site analyses has been carried out on 8 sites and property owners are awaiting reports. The opportunity here is to create a Koura industry in the district and there are several interested parties who are already considering opportunities to add value to the industry within the district through tourism activities and a restaurant for example. There are several more parties who have expressed interest in exploring the koura opportunity, and we will need 20-30 players to make an industry, so there is a lot more involvement needed from Trust. The initial eight parties will need further support to make the opportunity a reality. The Project Manager position is essential in enabling this to happen.

#### Trust Actions:

The Trust continues to source funding to engage a project manager to continue the progress already underway in all the above areas and will apply for grants to get this position in place.

## 1. PURPOSE

1.1 To present to the Māori Standing Committee the draft WDC Economic Development Plan.

## RECOMMENDATION

The Economic Development & Engagement Manager RECOMMENDS that the Māori Standing Committee receives the draft WDC Economic Development Plan and provide feedback.

## **EXECUTIVE SUMMARY**

The draft WDC Economic Development Plan provides a draft vision and actions for economic development across the Wairoa district.

## 2. BACKGROUND

- 2.1 Following the launch and implementation of Matariki the Hawke's Bay Regional Economic Development Strategy (HBREDS), (launched July 2016) and He Huarahi Hei Whai Oranga the Tairāwhiti Economic Development Plan (launched February 2017), the draft WDC Economic Development Plan has been developed ensuring appropriate alignment.
- 2.2 Following a Council meeting (24 November 2015) it was resolved *"THAT a workshop on the Draft Economic Development Strategy be included on the next Forum agenda."* This workshop was held and Councillors asked that a plan be developed following the launch and implementation of regional ED strategies.
- 2.3 The draft WDC Economic Development Plan now takes into account regional strategies and provides direction for the economic development vision and activities going forward.
- 2.4 This plan will be an organic document with the intent that it be adjustable subject to local, regional and national priorities, funding streams that become available, and partnership opportunities as they arise.
- 2.5 This draft plan will go through an iterative process before being tabled at the next Council meeting.
  - 2.5.1. Feedback sought from the Economic Development Committee (27 June 2017);
  - 2.5.2. Draft to be tabled at the 13 July 2017 Māori Standing Committee meeting and feedback sought from members.
  - 2.5.3. Final draft to be tabled at the 1 August 2017 Council meeting.

## 3. OPTIONS

- 3.1 The option identified is:
  - a. To receive the draft WDC Economic Development Plan and to provide feedback.

  - 4.8.3. Final draft to be tabled at the 1 August 2017 Council meeting.
- 4.9 Tangata whenua views are important and it is intended that this plan will include appropriate tangata whenua views. The Wairoa District Council Māori Standing Committee will be a primary mechanism for ensuring that these views are sought.

## Māori Standing Committee

4.10 This draft Wairoa District Council Economic Development Plan is now being tabled at the July 13 Māori Standing Committee meeting and views of members and tangata whenua will be sought and incorporated.

## 1. PURPOSE

1.1 This report provides information for the Māori Standing Committee on Council and community activities.

## RECOMMENDATION

The Māori Relationships Manager RECOMMENDS that the Māori Standing Committee receives the report.

## 2. MĀORI AFFAIRS SELECT COMMITTEE FEEDBACK

- 2.1 On 12 May 2017, the Council and Māori Standing Committee presented their recommendations to the Māori Affairs Select Committee for the Iwi and Hapū of Te Rohe o Te Wairoa Claims Settlement Bill.
- 2.2 The Wairoa District Council have since received feedback from the Māori Affairs Select Committee indicating that they accepted the recommendations put forward by the Wairoa District Council and the Māori Standing Committee. Suggested amendments to the Draft Bill have been made and will be considered at the next reading.
- 2.3 The Economic Development and Engagements Manager (Kitea Tipuna) replied on our behalf.

## 3. HAWKE'S BAY REGIONAL COUNCIL SUBMISSION HEARING

3.1 Many thanks to Paul Kelly (Deputy Chair) who spoke to the submission on behalf of the Māori Standing Committee on Monday, 12 June 2017.

## 4. **REPORTS**

- 4.1 The Māori Standing Committee received one written takiwā report at the time the agenda was sent to members.
- 4.2 Attached is a report from Wairoa Matangi Rau takiwā Paul Kelly.
- 4.3 If any member wishes to submit a verbal report, please indicate at the start of the Māori Standing Committee ordinary meeting on 13 July 2017.

## 5. ROAD NAMING WORKSHOP

- 5.1 Many thanks to everyone who participated in this workshop on Wednesday, 14 June 2017. We have now completed the preliminary part of this project. The next stage is for the GIS Co-ordinator (Russell McCracken) to collate all the information into the respective takiwā and forward to the Māori Relationships Manager for disbursement to the takiwā representatives. The Māori Relationships Manager will liaise with each representative about how this is presented to each takiwā.
- 5.2 There are several other stages to be completed. The Māori Relationships Manager will collaborate with the Transport Asset Manager (Libby Young) to assist with each stage (if required).

## 6. EFFECTIVE MEETINGS AND STANDING ORDERS WORKSHOP

6.1 Many thanks to all those who attended this informative workshop on Wednesday, 28 June 2017.

## 7. REMUNERATION (EFFECTIVE 1 JULY 2017)

- 7.1 To confirm, the new remuneration rates for the Māori Standing Committee took effect on 1 July 2017, as per the Māori Standing Committee remuneration workshop on Monday, 1 May 2017.
- 7.2 The new remuneration for the Māori Standing Committee is as follows:-
  - 7.2.1. Chair (\$265), Deputy Chair (\$230), Members (\$200), Marae Koha (\$600), Mileage (\$0.73/km already in effect).

## 8. TE KAWA O TE UREWERA DRAFT DOCUMENT

- 8.1 On 22 May 2017, we received a copy of the Te Kawa o Te Urewera document, which is the draft management plan for Te Urewera.
- 8.2 The Wairoa District Council has been invited to make a written submission on the draft document. We have read the document and have determined that the document has no direct impact on the Wairoa District Council, nonetheless, it is recommended that the Wairoa District Council (including the Māori Standing Committee) make a written submission in support of the overall document.
- 8.3 Submissions must be received no later than 5.00 pm on Thursday, 20 July 2017.
- 8.4 It is recommended that the Māori Standing Committee discuss and resolve whether the Māori Standing Committee will make a written submission in support (or not) of the Te Kawa o Te Urewera draft document.

## 9. WASTEWATER CONSENT STAKEHOLDERS GROUP

- 9.1 The stakeholders group has now visited several different treatment plants including Wairoa, Hastings and Waipukurau in the process of considering the best practicable option for the new consent.
- 9.2 The Project Managers (Neil Cook and Hamish Lowe) will present an update at the next Council Forum on Tuesday, 11 July 2017.
- 9.3 The group is working towards making public presentations by the end of July, beginning of August.

## **10. MĀORI POLICY UPDATE**

- 10.1 At the previous Māori Standing Committee hui (June 2017) it was resolved that the Māori Policy will be updated to reflect the role of the Deputy Chairperson. It was decided that the primary role of the Deputy Chairperson will be to assume the role of the Chair in the absence of the Chairperson.
- 10.2 The Māori Relationships Manager and the Governance Advisor and Policy Strategist (Charlotte Knight) will oversee that the policy is duly updated.

## **11. SITE BLESSINGS FOR SIGNAGE**

- 11.1 By the time of writing this report, numerous site blessings throughout the district were completed, including new boundary signs at the northern entry (Wharerata Hills), southern entry (Kotemāori), War Memorial Park (Sir James Carroll, AFFCO) and Black's Beach (surfing locations).
- 11.2 We once again acknowledge Bill McRoberts, Kuki Green and Kiwa Hammond who conducted the respective site blessing.

## **12. TE REO MĀORI POLICY SUBMISSION HEARING**

- 12.1 Submissions for the Te Reo Māori Policy closed on Friday, 30 June 2017. At the time of writing this report we have received fifteen (15) submissions, all supporting the adoption of the policy. We also received two submissions indicating their wish to speak to their respective submissions.
- 12.2 A submission hearing was being organised and a date of Tuesday, 11 July 2017 was being considered. The Māori Standing Committee resolved (8 June) that K Hammond, H Mita and H Nissen represent the Māori Standing Committee at the hearing.
- 12.3 A significant issue is the potential requirement for a transator to be made available for the hearings and there are submissions that need to be translated before they are put before the Council. Due to this, Governance Advisor and Policy Strategist has requested that the Te Reo Māori Policy hearing be delayed until such time that a suitable date can be agreed on. This will be discussed further at the upcoming Māori Standing Committee hui (13 July).

## **13. TE MARUATA HUI – 22 JULY 2017**

- 13.1 At the previous Māori Standing Committee hui (8 June 2017) it was resolved that K Hammond and S Cooper would represent the Māori Standing Committee at the upcoming Te Maruata hui to be hosted in Auckland at the Sky City Casino.
- 13.2 On 28 June 2017 (during the Effective Meetings and Standing Orders Workshop), S Cooper informed the Chair that she was no longer able to attend the hui and it was decided by those Māori Standing Committee members that T Thornton will replace her.
- 13.3 It is recommended that the Māori Standing Committee resolve to accept T Thornton as the replacement for S Cooper at the upcoming Te Maruata hui in Auckland (22 July 2017).

## 14. MANA HUIA LIMITED – MANA TOMLINS

- 14.1 On Friday, 9 June 2017 the Māori Relationships Manager met with Mana Tomlins. Mana has set up a new venture called Mana Huia Limited. The focus of her business is to offer advice and guidance for better utilisation of Māori land.
- 14.2 We have invited Mana to give a short presentation to the Māori Standing Committee at the upcoming Māori Standing Committee hui.

## 15. STATUTE BARRED RATE ARREARS WRITE-OFF 2009-2010

- 15.1 At the recent WDC Ordinary Meeting (20 June 2017), the Chief Financial Officer (Gary Borg) presented a report to the Council regarding the Statute Barred Rate Arrears 2017.
- 15.2 The purpose of this report was to seek approval of Council to write-off statute barred rates arrears of \$293,306.25 (incl GST) for the year ending 30 June 2010. It was determined that 95.2% (\$279,256.86 incl GST) of this write-off are rates arrears on Māori freehold land. Ownership structures unique to Māori freehold land prohibit effective collection of rates assessed and rates arrears for Māori freehold land are often unrecoverable.
- 15.3 It was resolved at Council that this matter be referred to the Māori Standing Committee for discussion and consideration. Historically, this procedure has been perceived as an administrative accounting function, however, in view of the nexus between Māori freehold land ownership and uncollectable rates, involvement of the Māori Standing Committee will be important into the ongoing debt management process.
- 15.4 The Economic Development and Engagement Manager will present a report to the Māori Standing Committee. We have also invited the Chief Financial Officer to attend to make a small presentation and to provide clarity around possible solutions to this matter.

## **16. CONCLUSION**

- 16.1 The Māori Relationships Manager will co-ordinate with Māori Standing Committee members regarding the next stage of the Road Naming project.
- 16.2 That the new remuneration for the Māori Standing Committee came into effect on 1 July 2017.
- 16.3 It is recommended that the Māori Standing Committee resolve to make a written submission in support of Te Kawa o te Urewera draft document, which closes on Thursday, 20 July 2017.
- 16.4 That the Māori Relationships Manager and the Governance Advisor and Policy Strategist duly update the Māori Policy to reflect the role of the Deputy Chair.
- 16.5 It is recommended that the Māori Standing Committee resolve to accept T Thornton as the replacement for S Cooper at the upcoming Te Maruata hui in Auckland (22 July 2017).
- 16.6 That the Economic Development and Engagement Manager submit a report regarding the Statute Barred Rates Arrears.

I attended with the MRM, and we facilitated the workshop and discussed the function and purpose of the Māori Policy and how it relates to the WDC. The NCC are looking at adopting a policy for thei Māori Consultative Committee. The workshop was well received.

## 21/5/2017 - Taihoa Marae Hui (Takiwā)

Attended by MRM and myself as MSC rep. We discussed how we could help with tree management on SH2 roadside. Trying to reduce the speed limit on SH2 outside the Marae. Look at a turning area now that double yellow lines are outside the marae.

## 18/5/2017 - MSC Road Naming Hui 1

The MSC went through the list of street names and checked for spelling mistakes and correctness. Only half the list was completed, the other half will be completed at another hui.

## 16/5/2017 - WDC Economic Development Committee Meeting

He spoke to us about the likelihood of a third School of Medicine being proposed for Waikato University. ## 5/5/2017 - River Hui – Wairoa District Council

A special meeting was called by His Worship the Mayor, Craig Little to discuss the condition of the Wairoa river and the bar. The hui was called at the request of Cr Rex Graham (Chairman HBRC) and was attended by two other HBRC Councillors, Cr Paul Bailey and Cr Fenton Wilson. WDC Councillors were also present namely Cr Jeremy Harker, Cr Charles Lambert and Cr Mike Bird. The MSC were represented by Kiwa Hammond (Chair) and myself (Deputy Chair). Also in attendance were the Engineering Manager (Jaimie Cox) and the Māori Relationships Manager (Duane Culshaw). Cr Graham wanted to hear from us the true situation and condition of the river and the bar.

I told the meeting that for some 75 years the situation at Kihitu/Ngamotu has been the same. Every time the bar blocks or partially blocks the paddocks flood causing stock to be lost and having to be moved some times in the middle of the night. All kinds of rubbish that comes down the river ends up at Kihitu/Ngamotu including sewerage discharged on the high tide. Rats move ahead of the rising water and the houses becomes their focus. These are river rats – big ones.

Cr Harker spoke about a time when he was at Kopu Rd in knee deep water on the phone to HBRC, and they told him that according to the computerised monitor the river was not in flood. The monitor is currently situated Awamate on the rail bridge.

The hui identified that not enough was being done by HBRC for the river and the bar. Cr Graham has called for a full report on the matter.

## WDC Waste Water Stakeholder Focus Group

*Background* - The Wairoa wastewater treatment requires re-consenting, with the current consent due to expire in May 2019. The major consent non-compliance issue with the present system and a major issue to be addressed in re-consenting is the recurrence of wastewater overflows into the Wairoa River from manholes and pumping stations during times of heavy rainfall and high river levels.

The purpose of this Stakeholder Focus group is to characterise the issue of uncontrolled overflows from the waste water system in light of available and existing data and to recommend options to manage these issues, namely the best practicable option.

The Stakeholder Focus group will provide valuable input into the project and will ultimately make a recommendation to the Council for their final decision.

The first meeting of the Stakeholder Focus group was held at the Memorial Hall on 10/04/2017. The new group was welcomed and introduced. They are:-

The purpose of Stakeholder Focus Group was explained, it is to get a good cross section of the community of Wairoa to gain feedback from the discussions. Roles and responsibilities were outlined. The group was asked not come with preconceived ideas and no hidden agendas.

An overview of Wairoa's existing wastewater system was described by the project team to familiarise stakeholders with what we have currently. The stakeholder group is to carry out public engagement and get an opinion of what the public thinks. Issues and problems with our current system was discussed and resource consents was discussed and explained also. A suitable name for the group was discussed and it was agreed that a name would come as time goes on.

This meeting was concluded.

The second meeting was convened at the Wairoa Airport lounge, due to a last-minute hiccup with a double-booking issue. The name of the focus group, Te Tini o Rangihoua, was introduced by Māori Relationships Manager, Duane Culshaw. This name will represent the many names and functions of Rangihoua.

A discussion was held around the basics of waste water treatment, reticulation pumping and pipes, discharge and the environment, the contributor to water health within the Wairoa River catchment and an explanation of the consent process and why they are needed. A discussion around Māori wastewater management was briefly touched on. It is planned to revisit this at a later hui.

A discussion took place on how to develop options. Main areas were centred round environmental, recreational, financial and cultural aspects. This turned out to be an in-depth discussion and produced a clear pathway for the future development.

This meeting concluded.

## 7/3/2017 - Local Government New Zealand Te Maruata Hui

Attended the LGNZ Maruata hui hosted by the Auckland Council. This hui was for elected and selected members, of Māori decent. The WDC was represented by myself, Kiwa Hammond and Cr Charles Lambert. We also noted other Wairoa and Kahungunu representations in attendance such as Allen Smith (Tātou Tātou o Te Wairoa), Cr Apiata Tapine (NCC), Brian Gregory and Paul Sciascia (HBRC MC) and Bayden Barber (HDC).

The day included a great deal of discussion, information sharing, and networking (whanaungatanga). A number of attendees from other local authorities were quite taken with how the Wairoa District Council and the Māori Standing Committees operates and have expressed a desire to visit to learn more as they see (and we already know) Te Wairoa as a unique example of how Māori worldviews and priorities are acknowledged and empowered in a local government context. In saying that there was a great deal to be learned from other district councils and there seems to be a clear willingness to share information that will help local government perform more effectively for their respective communities.

## 21/2/2017 - WDC Economic Development Committee Meeting

MĀORI LAND DEVELOPMENT AND COMMERCIALISATION PROJECT, was developed and presented by Te Mātārae o Te Wairoa Trust. (The Horizon Trust). Background -

- 1. To assist Māori Landowners to develop non-productive and under-producing Māori owned land.
- 2. To promote best land usage for the purpose of sustainable commercialisation.
- 3. To develop businesses with a focus on bio-diversity, Matauranga and sustainability by Māori Land owners.
- 4. To create employment opportunities and on-the-job-training.
- 5. To improve community well-being.

The committee resolved that it recommend to the Wairoa District Council that it support the Māori Land Development and Commercialisation Project (that support being a financial contribution of \$10,000.00 to the project).

## Māori Standing Committee Membership.

Kiwa Hammond - Te Wairoa Hōpūpū (Chair) Paul Kelly - Te Wairoa Matangirau (Deputy Chairman) Hereturikōkā Nissen - Ruakituri Peter Whaanga - Mahia Mai Tawhiti Sharon Cooper - Waikaremoana. Whai-ora Maindonald - Te Wairoa Hōnengenenge Theresa Thornton - Pāhauwera Henare Mita - Rakaipaaka Adrian Manuel - Te Wairoa Whānui We have had six hui this year. Although the Council has resolved to only meet every six weeks, the MSC will still be meeting monthly.

The February hui centred around the selection of a Chairman and recommending to Council the preferred selections for Council representatives on the Māori committee.

The Chairman's positon, two nominations were received, being Kiwa Hammond and Paul Kelly. It was resolved that the Chair will be Kiwa Hammond and Paul Kelly (Deputy Chair). The Deputy Chair is a new position within the MSC.

Four Councillors were considered for the MSC. They incumbent's Cr Mike Bird and Cr Hine Flood. Cr Jeremy Harker and Cr Charles Lambert were also considered. Due to the monthly MSC hui being changed from Friday to Thursday, this ruled out Cr Bird and due to and increased workload and commitments to the HBDHB, Cr Hine Flood was ruled out. Thus, Cr Jeremy Harker and Cr Charles Lambert were recommended and subsequently approved by Council.
