1. PURPOSE

1.1 This report provides information for the Māori Standing Committee on Council and community activities.

2. UPDATES (INFORMATIONAL)

- 2.1 This is an update from the previous minutes (July) of the Māori Standing Committee.
- 2.2 Client Service Request a kindly reminder for Māori Standing Committee members to refer any repair requests or complaints to the Client Service Request form (accessible via the Council website Request It Fit-it or Report it). This will ensure a prompt response to any matter.
- 2.3 Council Forum Rotation the Māori Standing Committee resolved that they will rotate members to attend the Council Forum's to include the Chair and one other member (rotational). The following members are rostered for the next three Council Forum's Tuesday, 14 August Sharon Cooper, Tuesday, 25 September Whai-ora Maindonald, Tuesday, 6 November Hereturikōkā Nissen.
- 2.4 Salute Wairoa Dedication the dedication for the touch table (currently located in the library) was conducted on Saturday, 21 July 2018 at the Wairoa War Memorial Hall. Many thanks to those who attended. At the same time, another touch table was blessed at the Wairoa Musuem, which also has the same information regarding Salute Wairoa. The event was a success and the touch tables are proving a well-deserved asset and resource for the community.

2.5 **Remission of Rates for Land Used for Papa Kāinga Housing** — as discussed at the previous Māori Standing Committee the Senior Rates Officer submitted a report to Council regarding the Policy for the Remission of Rates for Land Used for Papa Kāinga Housing. A workshop with Councillors is yet to be confirmed.

3. MSC REPRESENTATION - MĀHIA MAI TAWHITI (DECISIONAL)

- 3.1 On Sunday, 29 July 2018, the Māori Relationships Manager attended the Māhia Māori Committee monthly hui at Tuahuru Marae. During this time the selection process for a representative for Māhia Mai Tawhiti on the Wairoa District Council Māori Standing Committee was concluded.
- 3.2 We are pleased to announce that Fiona Wairau was selected to replace Anaru Te Nahu, who resigned earlier this year.
- 3.3 As a matter of protocol the process went as follows:- Apaapa-ā-Rangi Marae nominated, Tuahuru Marae seconded, Ruawharo Marae, Te Rakato Marae and Kaiuku Marae (abstained from voting, but agreed in principle) all supported the nomination. Mahanga Marae was absent.
- 3.4 A nomination (via email) was received, however, no one seconded the nomination and the nomination was defeated.
- 3.5 It is recommended that the Māori Standing Committee resolve to accept the selection of Fiona Wairau as representative for Māhia Mai Tawhiti takiwā.

4. REO KI TUA SYMPOSIUM (INFORMATIONAL, DISCUSSIONAL AND DECISIONAL)

- 4.1 Ngāti Kahungunu Iwi Incorporated will be hosting the third, Te Reo ki Tua Language Revitalisation Symposium on **Thursday, 23 August and Friday, 24 August 2018** in Hastings. This symposium will showcase some leading te reo Māori experts, as well as an array of second-language learners who have made careers out of their passion and dedication to the revitalisation of te reo Māori.
- 4.2 The theme for this year's symposium is "Karawhiti Taua Deploy the Language Army" and aims to inspire second-language learners.
- 4.3 There is an opportunity for the Māori Standing Committee to send representatives to attend this two-day symposium. The agenda for the symposium has been attached.
- 4.4 It is recommended that the Māori Standing Committee discuss and resolve the option of sending representatives to attend the Reo Ki Tua Language Revitalisation Symposium on Thursday, 23 August and Friday 24 August 2018.

5. MÃORI STANDING COMMITTEE MEETING SCHEDULE 2019 (DISCUSSIONAL AND DECISIONAL)

- 5.1 We seek direction from the Māori Standing Committee as to their preferred meeting schedule for 2019 once per month or six-weekly. The meeting schedule for 2019 will be presented to Council on Tuesday, 4 September 2018 for confirmation.

6. MĀORI STANDING COMMITTEE HUB PLATFORM (DISCUSSIONAL AND DECISIONAL)

- 6.1 We seek direction from the Māori Standing Committee as to whether they wish to fully utilise the services of the HUB. Currently, the Chair and the Deputy Chair have been trialling this resource. This will result in agendas no longer being printed for each meeting.
- 6.2 The Governance Advisor and Policy Strategist can give a brief explanation of the service and the cost to the Māori Standing Committee members.
- 6.3 It is recommended that the Māori Standing Committee discuss and resolve to decide whether representatives will/will not utilise the HUB platform.

7. COUNCIL REPRESENTATION (INFORMATIONAL)

- 7.1 On 24 July 2018 the Council resolved to adopt its initial proposal as the Council's final proposal, namely; *a Mayor* to be elected over the entire district (all registered Electors will have the opportunity to vote); *three (3) Councillors* elected at large from the *General Ward* (Electors registered on the General Electors Roll will have the opportunity to vote); and *three (3) Councillors* elected at large from the *Māori Ward* (Electors registered on the Māori Electors Roll will have the opportunity to vote).
- 7.2 There will be no Community Boards.
- 7.3 Members of the public have a one-month (30 July-24 August) objection/appeal period as per the Local Electoral Act. Should any objection/appeal be received, the matter is then required to be forwarded to the Local Government Commission for determination.

Client Request Service:

Thank you to council staff for their quick response to my request. Thank you also for keeping me informed about marae road signage. We are fortunate Aunty Liz Hunkin was available to advise us.

Tahaenui Bridge:

It is a relief to have our bridge back. People familiar with this stretch of road realise that traversing Tahaenui Bridge in the face of oncoming heavy traffic offers some risks, and so the new one-way signs and painted lines are a welcome precaution.

Kokohu Road, Tahaenui:

There is one family living up Kokohu Road, who are overjoyed with the tar-sealing of their road. Years of regular correspondence and the odd personal submissions concerning the hazards of dust from this road, have finally brought rewards. It has been a huge victory for them.

Tāne-nui-ā-rangi Marae:

Hosted final-year hauora students for an overnight stay. Viewed as a way of promoting life in rural New Zealand, and engaging Māori customs and protocols. We trust they will gain invaluable insight that will assist them in their chosen fields. It is important that these initiatives continue.

The Wairoa Star:

There have been some very interesting reports from The Wairoa Star over the past few months. It is good to see progress being made with the huge subsidence up Nuhaka River Road.
