#### 1. PURPOSE

- 1.1 This report provides information for Council on submissions received on the Recycling Centre & Landfill days consultation. Submissions closed at 4.30pm on Wednesday 30 January 2019.

#### RECOMMENDATION

*The Policy & Governance Team Leader RECOMMENDS that Council receive the submissions and thank the submitters for taking the time to make a submission.*

#### 2. BACKGROUND

- 2.1 Council consulted the community on either a service level change or an overspend on the budget as a result of the 18/03 Contract for Solid Waste Management Services tender process. Council had already consulted the community during the LTP process and made a decision to reduce the opening days of the landfill to 6 days.
- 2.2 Council received 21 submissions on the consultation matter – 20 did not wish to speak to their submission, 1 person does wish to speak to their submission.
- 2.3 Of the 21 submissions received – 2 prefer option 1, 18 prefer option 2 and 1 does not prefer either option.
- 2.4 Some submitters also made comments with details of how they thought their preferred option should be carried out. Comments included changing opening hours, specifying days, fly dumping, and rates increases.

Recycling is already pretty bad, particularly at weekends. And the current giveaway set up at the weigh-in &amp; payment area for rubbish deposits will cause congestion where will people could well end up having to wait long periods of time just to pay for the rubbish they've dumped! People will rightfully get impatient which then might encourage them to drive off without paying and who could blame them when there are only so many hours in a day to get other things done!</p> <p>Why has the WDC only come up with 2 options? Who did they send to communities like Raglan, where waste disposal has become a business being able to employ a large number of local people? And what did this WDC employee report back as to why this wasn't an option for Wairoa to consider? In reality, the WDC haven't done this have they! Why not?</p> <p>As a consequence of Option 2 probably going to be the preferred option as the Wairoa community already feel that they're paying too much in rates already, what is the WDC preparing, come the time that their budget for landfill won't cover the costs of being open 4 days a week? This is what will happen with Option 2! It only covers the here &amp; now and not thinking long term, in much the same way that WDC 10 year plan completed just last year didn't account for what is happening right now.</p> <p>I'm not impressed with the 2 options for dealing with landfill suggested by the WDC.</p>

<b>Comments</b> <p>All the problems with fly dumping began when the council locked the gates and started to make people pay.</p> <p>Open the gates at 7am weekdays so people on their way to work can dump.</p> <p>Close the dump between 10 and 4pm and then reopen the dump between 4 and 6pm.( 7pm in summer). Sat and Sunday keep the current hours.</p> <p>Have the dump open 7 days a week but at the hours stated or hours that allow people to dump when they are NOT WORKING.</p> <p>The council should be managing it not contracting out to people who are trying to run it at a PROFIT.</p> <p>This should be a service for the community, not a profit-driven enterprise. Why doesn't the council manage the dump/recycling?</p> <p>I have driven up there to do recycling. I am met with surly workers who are sitting behind a counter with their feet up and who don't budge an inch to help. If the dump/recycling centre is not cost effective It is probably because it has not been managed correctly. The people manning the booth have always been polite, but why does there have to be 2 digger drivers and why do they have to be there all day.</p> <p>I wonder if the contract was offered to the people currently employed at the dump if they could do it for the required amount. If they had a vested interest they actually might work a little harder.</p> <p>Giving people 2 impractical options is not consultation. It is a waste of time and money. Maybe the council should fire a few of the Public relations staff, spend less of doing up the business area ( AGAIN ) and redo the budget.</p> <p>Has anyone done a study at the dump to find the most used or underused time periods? Did the council survey the people to find out WHEN they would like access to the dump?</p> <p>If people were actually CONSULTED and knew their opinions and ideas would be listened to they would probably have more respect for the no-fly dumping rule and do more to keep the dump clean.</p> <p>I would love to speak to my submission but as a WORKING ratepayer taking time off work to go to a meeting that is scheduled during working hours is just further insult.</p>
