3. UPDATES (INFORMATIONAL)

- 3.1 This is an update from the previous minutes (February) of the Māori Standing Committee (MSC).
- 3.2 Client Service Request a kindly reminder for MSC members to refer any repair requests or complaints to the Client Service Request form (Telephone complaint in or it is accessible via the Council website From Home Page, click on the Envelope icon (top right of page), scroll down to *I want to...* click on Get Something Fixed. Fill out online form and click Submit).
- 3.3 *Council Forum Roster* the next three Council forum roster is **Tuesday, 9 April** (Henare), **Tuesday, 21 May (Fiona)** and **Tuesday, 2 July (Sharon)**. If you are

unable to attend your designated date, please inform the Māori Relationships Manager in the first instance.

4. REGIONAL DIGITAL HUBS (INFORMATIONAL)

- 4.1 On 4 February 2019, the Prime Minister Jacinda Ardern announced that \$21million will be invested in modern and reliable digital services for regional and rural communities.
- 4.2 Marae in remote communities will also benefit from the funding announcement as Regional Digital Hubs (RDHs) that will be established to enable marae to access digital services. The RDHs will offer services such as free wi-fi connectivity, co-working spaces and guidance on the use of the internet for business purposes.
- 4.3 Te Huki Marae (Raupunga) was one of three marae nationwide (Oromahoe and Te Houhanga marae both of Te Tai Tokerau) will be the first to receive the Provincial Growth Funding (PGF) for digital connectivity. The Prime Minister indicates '*Connectivity is an essential part of doing business while also enabling education opportunities and enriching community and family relationships*'. She further staes that this '*...investment will mean more communities will be able to enjoy the benefits of a digitally-enhanced economy*. (Source: Te Ao Māori Television, 4 February 2019)

5. WHITEWARE AND BULKY WASTE – (INFORMATIONAL)

- 5.1 We have been informed that a Whiteware and Bulky Waste programme will take place throughout the Wairoa district (excluding the township) within the next couple of months.
- 5.2 It will be duly advertised in The Wairoa Star and on the Council website. Once dates are confirmed, the Māori Relationships Manager will inform the MSC representatives accordingly to disperse information to their respective takiwā.

6. HURAMUA MARAE – (INFORMATIONAL / DISCUSSIONAL / DECISIONAL)

- 6.1 As most members are aware the whānau of Huramua Marae have been working towards repatriating fifty-three (53) tīpuna from Matiti Urupā to their new location at the marae.
- 6.2 This kaupapa is looking at starting on Monday, 1 April 2019 with the consecration of the land. The exhumation work will begin on Tuesday, 3 April 2019 in which the whānau are looking at exhuming and re-interring twenty-one (21) tīpuna over the coming week.
- 6.3 For the Māori Standing Committee's consideration, we are looking at sending a contingent from Council on Wednesday, 3 April 2019 to pay our respects and show our support for the kaupapa. Could the Committee please discuss this kaupapa and make a decision on whether they would like to be part of the contingent on behalf of Council.

7. KUPU WHAKAKAPI

'He Tukituki! Hī! He Tukituki! Hī! He Tukituki ki taku manawa! lahaha!'

E te matua, e te kaihaka, e te uri whakaheke a Hinepehinga, a Hine Hika, a Rongomaiwahine, a Mahaki hoki. Haere atu rā Percy ki a rātau mā kua whakapara kē i te huarahi māhau. It is my pleasure to present this Chairman's report for February 2019 with reference to early March 2019 (up to and including this Māori Standing Committee meeting, Thursday 14 March 2019).

Over the period that this report covers, in my role as MSC Chairman I was not required to attend many meetings requested by WDC or required to represent the MSC at other extraordinary meetings. Along with scheduled MSC meetings and workshops these included:

- WDC Workshop Discussion on Economic Development Draft (19/02/19)
- Māori Standing Committee (14/03/19).

Te Matatini ki Te Ao

A huge congratulations to our local kapa haka: Te Rerenga Kōtuku and Matangirau who represented Te Wairoa admirably at the recent Te Matatini National Kapa Haka Festival held in Wellington at the end of February. The presence of and support by local government representatives from around the country for the teams from their respective districts and regions was evident. In addition to the Wellington City Council representatives who were involved in a number of official occasions, our own Mayor Craig Little attended the festival to support our local kapa haka and was even spotted sitting on the ground just a few rows back from the front of the stage which shows a serious level of commitment – unlike his Gisborne counterpart, Mayor Meng Foon who was spotted in the comfort of the VIP lounge watching the competing groups on a TV screen as various Tairāwhiti groups performed on the rain swept stage outside.

All teasing aside it was interesting to note the emphasis placed on the active use of te reo Māori throughout the event. This was partly driven by the Wellington City Council in partnership with the Māori Language Commission, Te Puni Kōkiri, and other agencies. As a major urban centre, Wellington faces different challenges to Te Wairoa in regard to te reo Māori. As a rural area Te Wairoa can be proud of the fact that it does not require a major event to drive the use of te reo Māori. However, this does not mean that we should be complacent. As the winning kapa haka, Ngā Tūmanako stated in their waiata tawhito at Te Matatini it would be 'moumou' (wasteful) to let the efforts of the past be forgotten due to the neglect, ignorance, and complacency. Kia kaha tātau.

Whakarauora – The Regeneration of Long Water

Recently the Council conducted a workshop to discuss the draft findings of a Provincial Growth Fund supported report into the economic potential of the Wairoa District. This report, which has been compiled by the Giblin Group, provides an interesting snapshot of current business activities in the district as well as identifying potential opportunities that may be undertaken to further development and employment in our community. At the time this report was written the draft of *Whakarauora – The Regeneration of Long Water* was still going through a consultation process and undergoing amendment to ensure accuracy of details contained within. I look forward to the finalisation of the report and the possibilities it may create for growth and prosperity in our district in the years to come.

Road Works

Over the past weeks I have noted with interest the large number of road works happening throughout our region. Some of these are quite significant projects that represent a major level of infrastructure investment by the Council and NZTA which should be acknowledged. As more forestry blocks come online for harvesting in the next few years the pressure on roading infrastructure will hopefully be alleviated by the current improvements. In the short term, however, this does mean travel delays which can cause frustration. Therefore, let's encourage our friends and whānau to be mindful of the changing conditions on our roads.

I do not think they will have too much trouble getting the young ones involved with their digital programmes in schools. I was very impressed with Kiwa's presentation, as I am sure everyone else was.

The Giblin Report (Whakarauora – The Regeneration of Long Water), which the Economic Development Committee received was presented at an Extra-ordinary Meeting of Council. If you have the opportunity, please go online and read it. There is a section on the health of our people and you may be as shocked as I was to read the statistics.

Tawhiti-a-Maru Marae have finally got their Trustees problems sorted, thanks to the Māori Relationships Manager.

Huramua Marae are getting ready for the repatriation of their loved ones to their new burial site. Chaans Tumataroa-Clarke (Chair of Huramua) tells me they will start at the beginning of April and I know that our hearts and thoughts will be with them at that time.

Our serial burglar on Ruataniwha Road has been arrested. Some people have been hit at least 2-3 times and our marae has been burgled five times in the last 2 years, so we are instally cameras next week.

My report for this month focuses on the Council Forum (26 February 2019) where Christina Stockman presented to us. Christina is the Chairman of the Wairoa Waka Ama and she was presenting the groups plan to hold a Wake ama regatta at Mahia Beach. She showed us two planned courses both starting at Mokotahi down to Long point over to Waikokupu and home to finish at Mokotahi. A fantastic course that should test the best hoemahi. (See Appendix).

The shorter course starting at Mokotahi down to Moemutu across to Waikokupu and back to Mokotahi. Even this shorter course will test the best hoemahi.

A similar regatta held at Karapiro saw some 3000 people attend and it is expected that a smaller number will attend the Mahia Beach regatta but it will be interesting to see how Mahia and Wairoa will handle the numbers.

On another matter the marae in Matangirau takiwā are looking forward to the legal Memorandum of Understanding that is being written at the moment. This financial windfall has the potential to change marae as we know it.

Tēnā koutou katoa,

Raupunga Te Huki Marae

We are well into the rebuild of our marae, The main deterioration items were outside due to weather, have now been fixed. Frames completed in the kitchen and prep rooms and lined with Gib board. Water pipes connected to community supply, Concrete poured in ablutions and veranda areas; Electrician and plumbing work completed up to final fit out. Kitchen, prep room, Ablutions cabinetry have been measured will be made and ready for installation. Raupunga Te Huki are one of the first marae to receive PGF funding for digital connectivity.

Raupunga Community Water Supply

Once again a big thank you to Wairoa district council and QRS for the Halo Telemetry system, with all the problems we have had with silt and slash coming down the Mangawharangi it has made such a huge difference to the everyday running of the water supply, a lot less work for Guy Taylor who has been looking after it.

Waipapa-a-lwi Marae

A working bee was held for Waipapa-a-lwi marae to replace the outside boards which were in bad shape, Peter Maulder and a few of his building team removed the old boards while helpers painted the new boards ready to be hammered back on. The next working bee will see the outside walls finished, and a start will be made to reline the inside and also install batts to the round hall – Rongomaiwahine.

The drop outs on both roads into Mohaka have still not been fixed, we were told that the work on these jobs were meant to have started before Christmas, are we able to get a start date from the Council on this work before the whole road slips away, we are heading into winter and hope they can start work soon.

Kahungungu Marae

With a new committee they have not wasted time, they have been busy. The roof to the toilet block has been fixed from the ongoing leaks, new corrugated sheets have replaced the old, the blackberry has been cleared from the back area and all the rubbish has been removed, Guy Tekahika has fixed the fridge and freezer, also water blasted the storeroom ready for painting.

Te Rehu Marae

Te Rehu will be holding a Special General Meeting on the 6 April 2019. Concerns have been raised about our charter and strategic direction and so after some discussion, it was decided to host a meeting in Napier. This was done for a number of reasons. Many of our beneficiaries live in the Napier/Hastings region, and so it is hoped that we will get a good turnout to our hui. Te Rehu trustees had already met in early February, some coming from Hastings, Waipawa and Porirua to be there. To ease the burden on those trustees, it was decided that meeting in a more central location was best. Consideration was also given to our upcoming Annual General Meeting, which will soon follow our Special General Meeting. This meant further travel commitments for trustees and beneficiaries. Our Napier meeting then, a thoughtful compromise.

In addition to this, our secretary Jayell Smith, with the assistance of our chair, Charlie Smith and treasurer, Marion Lake has been working tirelessly on an Oranga Marae application for Te Rehu. It is hoped that the meeting will go a long way in piecing together a robust strategic plan, a necessary component of an Oranga Marae application.

Nuhaka School Gala

Communities are continuously on the lookout for different funding avenues. Our marae, churches, schools, sports teams and a multitude of other organisations are constantly looking to find funds, each one a worthy cause. Despite the fact that money in our many communities is limited, people remain generous. On the 22 March, Nuhaka School will hold its annual twilight gala, so, if you are looking for a venue with an excess of food and some fun antics, Nuhaka School should be your destination.

Mangaone Road

A couple of weeks ago, a Facebook post showed one of our local farmers trailering a load of round hay bales along Mangaone Road and journeying passed Johnina and Graeme Symes' home. Although a quaint country image, the reason behind the video clip was far more serious. At last years' Rakaipaaka welcome to our then new CEO, Graeme spoke about the dust from this road and its detrimental effect on his family's well-being. This has been a bane in their side for decades and with increasing traffic, especially heavy traffic, it has left the family frustrated. Laundry hanging out on the line requires a further wash, only to be dirtied again when someone else passes by. Dust settles on their roof, which after a rainfall flows into their tanks, and contaminates their water. Dust during the summer months is a constant companion. Last year, residents living along Kokohu Road were fortunate enough to have their road sealed after years of protestations from the likes of Matenga and Carol Hapi. The Symes family seek this same reprieve.

Nuhaka Rugby

On Saturday (2 March), Nuhaka went down to a more cohesive and skilled Maraenui team. At stake was the Bub Karangaroa trophy which had not been contested for many years. Nuhaka Domain was awash with people, locals and visitors alike. For a first run, both teams will benefit from the hit-out. This weekend Nuhaka participates in the Te Wero Trophy, hosted by Otane Rugby Club. The trophy includes netball and rugby. Tamatea and Mahia are the other teams involved in this tournament.

- 2. An invite has gone out to different Maori entities from our policy team to attend a hui on the 18 of March to discuss the Plan Change for Outstanding Freshwater Bodies. This is required as part of the National Policy Statement for Freshwater Management. The meeting will discuss the Outstanding water bodies for Northern HB. Further information can be found https://www.hbrc.govt.nz/hawkes-bay/projects/freshwater-bodies-project/
- 3. We will be meeting with GDC on Friday to discuss how to progress the Hill Country Erosion Fund Proposal in the Hangaroa and Mangapoike catchments.
- 4. We are still continuing in our attempts to obtain the final few signatures for affected party approvals for the Whakaki Freshwater Improvement Fund Project. This application has been submitted and is currently going through the consenting process
- 5. Raupunga water supply catchment work I will provide a verbal update.
