The Kaiurungi Matua Kaupapa Here me te Mana Ārahi | Senior Policy and Governance Advisor presented the report and reported on this review was commissioned by the five Hawke's Bay councils in August 2020 and stems from a Local Government Act (2002) s.17A requirement to review the cost effectiveness of Council arrangements for delivering services on a periodic basis.

In commissioning the Review, the councils' Chief Executives recognised that there might be opportunities to improve regional coherence of economic development investments and wanted a clearer picture of this in order to inform Long Term Plan processes starting from late 2020. Disruption arising from the Covid-19 pandemic resulted in later commissioning and completion of the review than had been anticipated and therefore there is insufficient time to finalise decisions in response to the review for incorporation in current 2021-2031 Long Term Plan processes.

His Worship the Mayor asked Mr Gus Charteris, Manager Economic Development, Giblin Group to give a quick overview. Mr Charteris advised Council the review found that broadly was offering right kind of services but were not resourcing it effectively and most resources were most subscale and have economic impact on Hawke's Bay.

Big opportunity for Maori in the economic space.

Ms Toni Goodlass advised still waiting on Business Hawke's Bay advise what their business is in terms of winding up and communicating.

#### **Elected members discussed:**

- Wairoa had not faired well, to have its own voice and the value it would bring to the community.
  - Stage 2 design of something, consultation needs to come back to the Wairoa community.
- Iwi participation reiterated the Hawke's Bay do not speak for Wairoa

The Chief Financial Officer RECOMMENDS that Council approves expenditure of \$271,351.52 for insurance premiums for the year ending 30 June 2021.


#### **EXECUTIVE SUMMARY**

#### 2. BACKGROUND

- 2.1 This matter is referred to Council because the financial commitment proposed exceeds officer delegation.
- 2.2 Council participates in insurance renewal negotiations with the Hawke's Bay 5 Councils Shared Services Group. In June 2020, the group participated in a collective tender with MWLASS. This process resulted in the Hawke's Bay Councils transitioning the bulk of its insurance arrangements to a different broker.
- 2.3 The policies covered by this matter are listed below:
  - 2.3.1. Material Damage (Commercial) all perils on above ground structures, value insured \$73 million
  - 2.3.2. Material Damage (Residential) primarily pensioner housing (14 units) and 4 dwellings on other Council property, value insured \$5 million
  - 2.3.3. Motor Vehicles 28 vehicles, value insured \$0.7 million
  - 2.3.4. Personal Accident
  - 2.3.5. Standing Timber
  - 2.3.6. Statutory Liability
  - 2.3.7. Employers Liability
  - 2.3.8. Travel
  - 2.3.9. Hall Hirers
  - 2.3.10. Crime
  - 2.3.11. Business Interruption

#### 8.2 MAHANGA WATER SUPPLY - UPDATE

#### 1. PURPOSE

1.1 This report provides information for Council on Community Assets and Services (CAAS) department responsibilities for on-going drinking water compliance.

#### **RECOMMENDATION**

The Pouwhakarae – Hua Pūmau Hapori / Ratonga Group Manager Community Assets and Services RECOMMENDS that Council receive the report, thus endorsing the improvements.

#### 2. BACKGROUND

- 2.1 This report provides an update for Councils on-going requirements to supply safe reliable drinking water to the Mahanga community.
- 2.2 Wairoa District Council as a Water Supplier is assessed annually for compliance to Drinking-water standards for NZ 2005 (revised 2018) and duties under the Health Act 1956.

#### 3. RESULT OF THE MAHANGA WATER SUPPLY CLOSURE REFERENDUM 2021

The Mahanga Water Supply Closure Referendum 2021 was polled February 2021. This was a referendum to consider views from property owners affected by the service of this water supply.

The result was declared by the Electoral Officer on the 19<sup>th</sup> February 2021 with the outcome that the Mahanga Water Supply will remain open.

The referendum saw 31 votes (59.61%) of voters in favour of keeping the Mahanga water supply open. 21 voters (40.38%) were in favour of the closure.

Under the Local Government Act 2002 a threshold of 75% of votes cast is required for the water service to close.

Due to the result of the referendum, Council will maintain the status quo with no further capital upgrade until the drinking water regulations are finalised by the Central Government Three Waters Reform.

Once finalised, Council is required to get a full options analysis report with the most up-todate costs. This will be required to validate a new water source, which will include easements, property acquisition and infrastructure.

#### 4. PROPOSED NEW DRINKING WATER STANDARDS AND RULES

The draft Water Safety Bill out for submission – stipulating residual disinfections for all public water supplies including small water supplies must be chlorinating their respective

reticulations. The Taumata Arowai Act is through which intends to bring the entity 'on-line' on the 1<sup>st</sup> July 2021. The draft drinking water standards are out which gives direction for monitoring residual chlorine there is enough information suggesting that this will be mandatory from 1<sup>st</sup> July 2021. #### 5. IMPROVEMENTS

- 5.1 Mahanga water supply is currently chlorinated however the system is very basic and is not monitored ie: has no accurate dose monitoring or alarming or resilience. A small package of work is planned to be done which will reduce risk and help ensure on going water safety.
- 5.2 The improvement work includes an additional concrete water tank, upgrading the chlorination dosing system, electrical controls, new SCADA monitoring with alarming, new smart meter volumetric data collection, and reservoir level monitoring.
- 5.3 Please Note: The improvement components such as, an additional concrete water tank, hardware and software for both the SCADA monitoring and the chlorination dosing system can be repurposed when the new Mahanga water treatment plant upgrade eventually occurs.

#### 6. COST

\$75,000: This will be funded from the 3 waters \$11 million Stimulus package, and will mean this is not funded by the rate payer; However will be subject to Department of Internal Affairs (DIA) approval.

Expected completion for improvement works are around September 2021.
