


#### 2.0 INTERCITY BUS

THE quick actions of Wairoa residents prevented a fire from getting out of control at Whakamahia Beach on Monday afternoon.

Emergency services were called when passers-by noticed a fire on the south side of Rangihoua (Pilot's Hill) near the car park around 2.45pm. Wairoa volunteer firefighters

managed to extinguish the fire with the support of contracting company Quality Roading & Services (Wairoa) Ltd (QRS).

Freedom camping ambassador Elizabeth Ormond said she and colleagues noticed people acting suspiciously in the area while monitoring the Wairoa freedom

camping sites.
"We were checking the Wairoa sites when we drove past the area and noticed a couple of

very suspicious.

"As we came back around we

noticed the fire and called 111 and waited for the fire brigade to arrive," she said. The fire was attended by Deputy chief principal fire

officer for Wairoa Tim Allan, who said the machinery was

who said the machinery was needed because the fire was very deep- seated.

"The Wairoa volunteers did a good job to put it out and were able to leave the site just before 5pm

"QRS remained at the site for another hour and a half

tor another hour and a hair to make sure it was fully extinguished."

Mr Allan said the fire was likely caused by people being careless in the area.

"This is a conservation area and people are putting wildlife at risk in that reserve. "Unfortunately, it has become

an area popular for fly dumping, which is terrible.

"It is disappointing that people are not more conscientious there and do not treat it with more respect.

#### **BUILDING WORK**

#### Courtyard, Retail & Hospitality Space

A Spatial and Interior Designer has provided written and visual concepts for the space, which are being refined to inform detailed designs. The developed designs has been finalised for the courtyard layout, with just the layout of the restaurant toilet space needing to be slightly reworked. Once this is resolved detailed designs will be completed in readiness for consenting. Consultation with the WDC building team has taken place to discuss compliance and provide direction around the toilet layout. Interior finishing's and fixtures for the

courtyard and retail development are currently being finalised, sourced

and costed.


#### **Concrete Work**

BBR Contech have been onsite at the Gemmell's site since mid-April completing a concrete repair programme on the beams and columns (pictured). On the advice of the project structural engineer concrete works will also include repair work to the smallest module of the courtyard in the retail space..

#### Consents

Consultation with the WDC regulatory team has taken place to discuss the project and update all parties involved ahead of consent submission. The consent for the entire courtyard will be submitted to Wairoa District Council in a staged process.

Building consent for construction of café pod shell is pending. The café pod will sit in the middle module of the courtyard by the street entrance. EIT Wairoa Level 3 Building and Construction students are building the pod shell as part of their practical course work. The final





Archaeologist Elizabeth Pishief has completed her assessment of the Gemmell's and Winter's sites and submitted a report to Heritage New Zealand. Vision Projects have submitted an archaeological authority application. Once Heritage New Zealand grants authority (expected by end of May), construction in the courtyard may begin.

#### TE WAIROA E WHANAKE - SITE SAFETY WEEKLY REPORT

#### Gemmell Building Site 184 Marine Parade, Wairoa

Updated: 3 May 2021

This weekly summary includes up-to-date information and details for the work site at 184 Marine Parade, Wairoa, commonly known as the Gemmell building (subsequently referred to as the 'site').

#### VISITORS/CONTRACTORS ONSITE

Last week the BBR Contech team continued its work repairing treating the beams and columns at the Gemmell's site. They currently have two scaffold towers on site which they store there overnight. They take all tools and equipment offsite at the end of each day.

#### 1.1 EXISTING AND NEW HAZARDS

Small pieces of concrete are hanging from exposed steel rods protruding from the exposed concrete beams. The pieces of concrete are currently stable but could become loose in the future. Full PPE is to be worn onsite at all times and efforts are made to avoid walking or standing under these areas where possible. The concrete floor is slightly uneven in places due to some broken sections. Demolition 1 Ltd will remove sections of the top layer of concrete in due course. There are three separate piles containing crap metal, scrap pieces of wood and general rubbish from the demolition. These will be removed in due course. They are kept to the side out of the way of pedestrian and vehicle access throughout the site. (Please see photos at end of report). There are new circular holes and other areas of missing concrete in the beams, columns and ground as a result of concrete testing.

#### 1.2 INCIDENTS AND COMPLAINTS

No incidents or complaints.

#### 1.3 INJURIES AND EMERGENCIES

There were no injuries or emergencies.

#### 2. EQUIPMENT LEFT ON SITE

No equipment is currently left on site.

#### 2.1 ACCESS

The only site access is via the Wairoa District Council-owned carpark at the rear of the site. There is a gate to the site with a chain and a combination lock attached. A hazard board has been installed on the gate detailing the current hazards post-demolition by Hawke's Bay company Demolition 1 Ltd.

#### 2.2 SUPPORT AND SITE VISITS

No non project-related site visits this week.

#### 2.3 UNAUTHORISED ENTRY

There has been no visible unauthorised entry to the site.


