#### 3. Local Activity update for September

- a) There has been good collaboration between HBRC & WDC compliance teams over a number of outstanding issues with dumping, storage of waste and earthworks recently. Given the multijurisdictional nature of these issues it has been great for the speed with which things are being followed up on.
- b) With the 90-100mm/24 hour rain event on the 17 September, both the Nuhaka River and Lake Whakakī were opened to lower their levels. There has been significant korero since the flooding around the position of the Wairoa River mouth and it has been interesting to see the range of views about that online. Something we will all need to korero about to find a good solution for it appears.

1.1. This report provides information for the Māori Standing Committee on Council and community activities.

Kua whiti atu tō tātou poutokomanawa ki te ora i tēnei ao matemate. Kua mutu tana rongo i te mamae, he taonga pāhekeheke tēnei kākahu taratara, kapua pouri. Āpōpō ka tau ki runga o tētahi, e pēnei ana te kōrero he puāwaitanga harakeke, he rito whakakīnga whāruarua, nō reria tēnā anō koutou.
- 2.4. Ko rātau te hunga mate, haere, haere, haere. Ko tātau te hunga ora, ngā urupā o rātau mā, whano, whano, hara mai te toki, haumi e...hui e...taiki e! Tihei mauri ora ki a tātau.

- 3.3. **Council Forum Roster** the next three Council forum roster is **Tuesday, 16 November** (Alex-Ann). If you are unable to attend your designated date, please inform the Pouahurea Māori in the first instance.
- 3.4. **Council Ordinary Meeting Roster** the next three Council Ordinary meeting roster is **Tuesday, 30 November (Alex-Ann)**. If you are unable to attend your designated date, please inform the Pouahurea Māori in the first instance.

#### 4. SPATIAL PLANNING (INFORMATIONAL)

- **4.1.** On Friday, 15 October 2021, Hastings District Council (on behalf of all five HB Councils) hosted the first spatial planning hui-ā-iwi at the Napier War Memorial Centre. In attendance were Henare Mita, Liz Palmer and Hinenui Tipoki-Lawton on behalf of the WDC Māori Standing Committee.
- **4.2.** Discussions were led by Bill Wasley and Shadrach Rolleston. Bill Walsley (Bill Wasley Consulting Ltd), is highly experienced in spatial planning and has been engaged to undertake a scoping project, which will ultimately set the parameters for a regional wide spatial plan.
- **4.3.** Shadrach Rolleston is a consultant planner and policy advisor with particular expertise in resource management and Māori relationship management in urban design.
- **4.4.** Both shared their experiences in spatial planning, which for the majority in attendance appreciated. They explained that spatial planning is essentially taking an integrated social, environmental, economic, biodiversity, natural hazards, climate change adaption and cultural well-being approach to the setting of the strategic direction communities wish to take over the next 30-50 years.
- **4.5.** Their key message was that collaboration is the fundamental key, particular with a strong focus on iwi partnership, which is vitally important to the strategic direction over a long period of time, but with the agility to cope with changing circumstances. This will require ongoing relationships with everyone, iwi and Councils, to join up connections and framework for having challenging and difficult conversations on several kaupapa.
- **4.6.** Mr Rolleston pointed out that Māori must have an effective role in this kaupapa, consistent with the principles of the Treaty of Waitangi and a greater recognition of including mātauranga Māori in the planning system, which will support and enhance treaty settlement arrangements.
- 4.7. The strategic thinking was to ensure that there was a clear partnership arrangement with regional and local authorities in regional spatial strategies and plan making, with a stronger role and influence for tangata whenua in participating in decision-making. This includes enhanced participation at every level in this planning from governance, senior management and technical advisory.
- **4.8.** There was an acknowledgement to certain issues, with rhetorical questions being raised such as, how do regional spatial strategies relate or interface with treaty settlements? How will tangata whenua appoint representatives to any proposed regional spatial strategy committee? How do you manage representation with expertise? What

- obligations or responsibilities do tangata whenua appointees to regional spatial strategy committees have to tangata whenua or iwi, hap $\bar{u}$ , etc, and who will fund tangata whenua participation.
- **4.9.** These types of questions have prompted those iwi-leaders in attendance to organise another iwi-led hui on this subject in due course, which will be hosted by Te Kāhui Ōhanga o Takitimu. We will endeavour to keep the MSC informed accordingly.
- **4.10.** We would encourage those who attended to give their respective feedback.

#### 5. LOCAL GOVERNMENT REVIEW (INFORMATIONAL)

- **5.1.** The Central Government is currently reviewing the future for Local Government. This is in light of the Government's perspective that Aotearoa is fast becoming a more varied population. Mixed into that is how climate change requires everyone to adapt and how the Treaty of Waitangi partnership model will re-focus on enduring and mutually beneficial relationships.
- **5.2.** The Government has commissioned an interim report named Ārewa ake te Kaupapa Raising the Platform, which can be viewed on the following link <a href="https://www.futureforlocalgovernment.govt.nz/">https://www.futureforlocalgovernment.govt.nz/</a>. This report lays out the general direction and priority queries in order to support engagement about the future of local governance and democracy.

#### 6. HBRC REPRESENTATION REVIEW SUBMISSION HEARING (INFORMATIONAL)

- **6.1.** On Wednesday, 13 October 2021 His Worship the Mayor Craig Little, Cr Chaans Tumataroa-Clarke, Henare Mita, Liz Palmer and Hinenui Tipoki-Lawton represented the Wairoa District Council at the submission hearing at the Hawke's Bay Regional Council (HBRC) submission hearing regarding the representation review undertaken by the HBRC.
- **6.2.** We would encourage those who attended to give their respective feedback.

#### 7. PRIVATE WATER SUPPLY PROJECT (INFORMATIONAL)

- **7.1.** The collective called HB5C, incorporating all Hawke's Bay territorial authorities and the regional Council, have commissioned a project to provide an overview of the Private Water Supply in light of the new Waters Services Act.

- 9.2. Cross over from the darkness to the light. Cross upwards, cross downwards. Turn to the rock, turn to the tree. Lean to this side, lean to that side. Alas the breath of life!

#### 10. CONCLUSION

#### Hawke's Bay Councils Private Water Supply Investigation Project Overview

#### **Project Purpose**

The Hawke's Bay territorial authorities (Napier City Council, Hastings District Council, Wairoa District Council and Central Hawke's Bay District Council) have commissioned an investigation, in advance of the Waters Services Bill enactment, with the Government's stimulus funding for Three Waters Reform.

This paper provides an overview of the Private Water Supply Investigation and approach to support the regions readiness, in anticipation of the new requirements under the Water Services Bill.

#### **Background Context**

- The Water Services Bill sets out a new requirement for Councils (territory authorities) to undertake water supply assessments of drinking water services.
- The assessments require Councils to:
  - Identify communities that receive a drinking water service
  - Describe the nature of the drinking water service and the characteristics of the community it serves
  - o Assess whether the water is sufficient to meet current and future demands
  - Describe the safety and quality of the drinking-water and identify any potential public health risks relating to the supply
  - Assess consequences if the community loses access to the services and outline a plan to provide for ongoing access to drinking water services
- · Following the assessment a Council must:
  - Make the assessment public and provide a copy to Taumata Arowai (drinking-water regulator)
  - Notify Taumata Arowai if any suppliers are, or appear to be, failing to meet statutory obligations, any absence or deficiency in a drinking-water service, and if there is a risk of a water supplier ceasing to operate a service
  - Consider any findings in relation to the Council's current and future Infrastructure Strategy,
     Long Term Plan and District Plan
- Where suppliers and communities face significant problems or potential problems with its drinkingwater services, Taumata Arowai may require the Council to work with the supplier, the consumers and Taumata Arowai to provide a solution to the problem. This may include taking over the management and operations for the drinking water service or providing drinking-water through an alternative arrangement.
- The Department of Internal Affairs has estimated that there may be over 75,000 private water supplies across the country. There could be around 2,700 private water supplies in the region, based on the current population of Hawke's Bay.

#### **Project Objective**

- Determine the number and location of private water suppliers in the Hawke's Bay Region based on existing information held by councils and other stakeholder agencies
- Develop and test an assessment and engagement approach with a sample of private water suppliers before the Water Services Bill is enacted
- Ensure that Hawke's Bay Councils understand how best to assess private water supplies; support their communities to provide safe drinking water; understand their resource and capacity requirements for the new requirements
- Where possible, influence the way these assessments are carried out, both in terms of the methodology and communications and engagement approach, across the rest of New Zealand.

There is an overarching commitment to determining a trusted and sustainable partnership approach, between Hawke's Bay Councils and their communities.

#### **Investigation Objectives**

The Councils have a good understanding of their own water supplies, so this investigation focusses on private water supplies. The objectives of the investigation are:

- To capture data and information on private water supplies to understand the current state (performance and risks) from a representative test sample within the Hawke's Bay region
- To develop a repeatable methodology for undertaking assessments of private water supplies
- To develop and validate a communications and engagement for future private water supply assessments
- To explore the communities' values and perceptions of water and private water supplies within the Hawke's Bay region
- To understand the expectations and needs of private water suppliers and their supplies within the Hawke's Bay region
- To investigate private water suppliers' understanding of safe and accessible drinking water within the Hawke's Bay region.

#### Investigation Methodology

The investigation will adopt a community-up research approach using a representative sample of private water suppliers. An aim of the community-up approach is to arrive at a shared understanding of the purpose and outcomes of the project, and to ensure a strong foundation for continued partnership can be achieved for future activity. A meaningful engagement is established through meeting people face-to-face, in their own time and place.

All stakeholders, iwi partners and communities participating in the research will receive and share information to review and reflect upon. This process will allow for trusted relationships, and the opportunity for on-going advocacy and supplier education.

#### **Timeframes**

The project will be delivered in a structured series of phases to meet the Three Waters Government Stimulus funding timeframes.

#### RIL Larry:

I am writing my report on Monday, 18 October 2021 after attending a service for Laraine (Larry) Symes, the youngest of Johnina and Graeme Symes' children, sister to Phillip and Rose, and beautiful mum to son, Jax. Her passing has been a tragic loss, one that has shaken us all to the very core. Tomorrow afternoon we will welcome her on to Te Rehu Marae, where her family can at long last, share the pain of her untimely demise. Questions abound but solutions are, as of yet, not forthcoming. What are we to do? How do we help our loved ones without alienating them? How do we free them from the terrifying grip of this parasitic drug?

We miss you Larry, we love you, and mourn your passing. Our hearts go out to your family, your nephews, nieces, cousins, aunts, uncles, and many cherished friends. Although stunned and bewildered, we know you reside in a place, absent of the terrible pain that lay heavily upon your troubled shoulders. We know you will be surrounded by a multitude of loved ones. Rest peacefully in their love and care Larry, we will cherish forever the fond memories you leave behind with us.

#### **HBRC Māori Constituencies Verbal Submissions:**

A small, but enthusiastic Wairoa contingent, made up of His Worship the Mayor Craig Little, Councillor Chaans Tumataroa-Clarke, Pouahurea Māori Duane Culshaw and Māori Standing Committee members Hinenui Tipoki-Lawton, Liz Palmer and myself travelled through to the HBRC offices in Napier. Ostensibly, we were there to present verbal submissions pertaining to the proposed HBRC Māori Constituencies. In truth however, when speaking about the proposed Northern and Southern Māori Constituencies, we were compelled to discuss the proposed boundary changes to the Wairoa General Constituency also.





Mayor Little and Councillor Tumataroa-Clarke delivered a comprehensive power-point presentation. They argued that the proposed boundary changes were detrimental to Wairoa realising a Wairoa-based representative in either the general or Māori constituencies. Wairoa was a small rural community, whose vote would be split into those on the Māori and General Rolls. Moreover, the increased boundaries, favoured the urban vote; those living in Napier and Hastings. They maintained, as a consequence, that Wairoa should be viewed as a 'community of interest', and that the Wairoa General Constituency should not be altered, just to satisfy an unworkable (+/-) 10% threshold. In addition, they argued that instead of having two overly large Māori Constituencies, there should be instead three smaller Māori Constituencies. In doing so, Wairoa stood a good chance of achieving two Wairoa-based representatives on the HBRC.

Liz and I spoke on behalf the Māori Standing Committee and in essence made the same arguments, although it was my contention that our proposal to offer three Māori constituencies, was in truth an act of desperation to satisfy the (+/-) 10% threshold. The HBRC proposal we saw as detrimental to Wairoa gaining Wairoa-based representation. And as a community that had fought hard to realise Māori constituencies, we found that unthinkable. All-in-all, I believe we gave of our best, and whether we were compelling enough advocates or not, only time will tell. But what was heartening to see, was the support afforded us by HBRC elected members Councillors Charlie Lambert and Apiata Tapine, along with HBRC Māori Standing Committee Co-chair Michelle McIlroy. Their comments and questions were helpful to Wairoa presenting a strong voice. I think too, the Councillors themselves gave us a fair and sympathetic hearing. It is incumbent upon us now, to mobilise Wairoa voters. If we want representation, come local body elections, we need to get out there and vote. Kia kaha rā tātau e te whānau!!!
