Tautoko Wairoa saw over a quarter-million dollars spent during the 5 weeks of the campaign. The campaign focused on retail and health and beauty stores. Winners were excited to receive the news with one person never receiving a prize from a draw before.

The business Support plan has been placed on hold, awaiting the Economic Development Agency funding decision to be confirmed and also Economic Development Stra completion, as this would impact the timeline of this work. The governance and ED officer took the opportunity to informally discuss the plan with business owners during Tautoko Wairoa campaign and it was suggested that a market analysis be completed to identify gaps in the market and duplications of products.

Members discussed the importance of having a strong business association for our businesses community, that could utilise local resources and knowledge, also this will create an open network to allow businesses to work together avoiding unnecessary competition from duplication of products. The Chair suggested that the ED committee can look at supporting and strengthening Upstream Wairoa.

Confirmation has been received from Dr. Sandy Adsett, a high callibore artist confirming he is onboard as consulting artist.

The next three months is full on and includes key funding deadlines.

Another important area the project is currently focusing on is engaging with mana whenua, guidance from local mana whenua and Maori liason officer has been provided to ensure this has been advertised broadly and appropriatly. A workshop date is set, and will keep manawhenua informed of the progress and also provide an opportunity for the project team hear the aspirations put forward so this can be incorporated into the design.

His Workship requestsed a workshop with elected members to discuss ensuring this facility has independence.

With the predictions of tourism to be higher than normal, due to neighbouring events like R n V cancelling and domestic tourist looking for next ideal destination to visit, this has increased the projected visitors expected to visit the Wairoa District.

Consistent messaging is key to keeping our community proctected we need to keep reminding ourselves and others to be safe and kind. To keep scanning in and wearing masks, now is not a time for complaicency. The best defence is vacinnation and adequte testing prior to entering town. Members are very worried about our most vulnerable.

## 8.5 FINANCE REPORT ON TE WAIROA E WHANAKE SPEND AGAINST BUDGET

The financial accountant presented a forecast on the 6.8 million dollar project. Significant changes to the construction industry post covid has caused price overruns. The rate of construction material increase in the last year and it forecasting to continue until project completion triggered the need to complete this forecast exercise to identify if the project is going to run over budget and if so look at mitigating this.

The forecasting shows there could be an overrun of \$650k-990k which is between 9-14% overrun, overall members agreed this isnt to bad for the value of the project and comparing against other projects around the Hawkes Bay that are hitting 20-30% overrun. Allot of this is due to Vision Projects been proactive and indentifying cost fluctuations and pre purchasing items like the steel. The need to continue locking in prices and ordering as you can will help reduce the amount of overruns.

With the uncertainty of material costs and the expectating of it continuing to rise until project completion, Vision Projects are looking at external funding and also discussing changing the scope and fit out that may see the project move from gold standard to bronze to reduce overall cost. Another option been considered is looking at delaying completion of stages in the project to seek further funding and repurposing money across the project. The Finance team reviewed the budget as a whole, to identify areas that may compensate forecast overrun.

Members agreed this needs to be communicated to the community aswell as the PGF. They also thanked the staff for proactive measures and bringing this to attention to allow this communication to happen. Elected members also stated it is really important Vision Projects and staff keep them in the loop and stay on top of this so it doesn't blow over to high. The Project team are mindful that while they are looking to reduce costs they need to ensure the building is durable and does not become a cost burden to future ratepayers

## 8.6 PAKIHI ORA - COVID PROTECTION FRAMEWORK

This item was reported to seprate to item 8.1 and 8.7 to Highlight the significance of this to our community. The ED team visited majority of the businesses and along with council workers and contractors, to provide information and flyers relating to the new Covid Protection framework . Key thing to highlight is that businesses are in 4 different categories and framework impacts are considerablly different.

Our businesses do not want to create division or enforce segregation that is not necessary so if they are not required to request a vaccine pass they wont do it. Mandatory mask wearing still creates continued resistance.

The food and Beverage businesses faced a difficult decision whether to go contacless and inclusive or serve those with vaccine passes only, making it a bigger headache. Staff are facing cyber bulling, abuse and it puts strain on these business to get staff to check passes whilst also trying to develop a contactless service to provide an option to those without a pass.

The information pack delviered to businesses provided details on how business can provide feedback relating to this framework so the ED team can collate and provide to central government. Overall it is a difficult time for our businesses and the words "covid fatigued, concerned for well being" where mentioned.

Chairman Cr Eaglesome Karekare mentioned she has been approached by a service that are willing to deliver a programm for businesses around stress level and well being and she will look at accepting this offer for our business community.

It was pleasing to see the community rally together to provide a service to support whanau to get a vaccine pass, that is one of the great things of our community. Members where reminded that we must also prepare for this again when they expire in the next six months.

Cr Kaimoana raised a point that local commissioning money and business hub money has been received in our community, Council needs to understand what is happening with these funds and confirm if support is available for our business community.

## 1. PURPOSE

- 1.1 This report provides information for the Committee on the Library Archives redevelopment project. It is a progress update and no decisions are required by the Committee at this stage.
- 1.2 A Council project team of five members representing the areas of Library, Archives, IT, Maori Relationships and Group Management represent this project. Vision Projects is contracted to deliver the Library Archives redevelopment project to the funding application stage. The Committee have requested that progress updates be delivered periodically.

## RECOMMENDATION

The Pouwhakarae – Pārongo / Wheako Kiritaki Group Manager Information and Customer Experience RECOMMENDS that Committee receive the report.

## 2. BACKGROUND

- 2.1 We have some good news to share with Elected Members about funding received for the Library Archives Redevelopment project. In January, it was confirmed that Council got approval for funding for the development of the preliminary plans for the project. Preliminary plans are the architecturally-designed concepts which show what the building will look like inside and out. The cost of this work was \$70,000.
- 2.2 Council originally underwrote this cost, and then we began to apply for funding to cover it. Happily both the First Light Foundation and Pam Torbett Trust came to the party and offered to pay half each. Both of these Trusts were pleased to hear about the project and what it will mean for the community, and they have congratulated Council for its approach. Receiving this money is a big win for Council because it reduces the cost to ratepayers while ensuring that the project moves forwards.
- 2.3 In addition to this funding, we have been also been successful in receiving another lot of funding to help pay for our cultural artist, Dr Sandy Adsett. These buckets of funding are in addition to the original \$80,000 received from National Library to fund the project management costs. This has taken the pressure off ratepayers, and has ensured that we're able to progress this work in a safe and efficient way.
- 2.4 We now have the first cut of conceptual designs and look forward to sharing these with Elected Members so that they can see what the building may look like. These early-stage concepts are subject to change and refinements will be made as feedback is collected.


- 2.5 The next stage will be to present the draft preliminary designs in a combined workshop for feedback and guidance. In the meantime, positive feedback has been received from mana whenua about the spatial and cultural aspects reflected in the designs and landscaping.
- 2.6 The preliminary designs will be used to apply for the significant funding for the actual build. This will provide a safe gate-point at which Council can decide whether to go ahead with the project.

## 3. EARLY STAGE CONCEPTS


- 3.1 The next two pages provide a glimpse of the early-stage concepts. These represent the aesthetics of the building exterior and the footprint and functionality of its interior.


*Figure 1:* The building as seen from Marine Parade looking southward in the direction of the existing Library and Council buildings.

- 3.2 *Figure 1* represents the building as seen from Marine Parade looking southward in the direction of the existing Library and Council buildings.
- 3.3 *Figure 2* represents the view as seen from under the covered entranceway looking northward towards the Wairoa river.

#### ACTIVITY REPORT: CENTENNIAL LIBRARY & ARCHIVE REDEVELOPMENT FUNDING

Vision Projects is contracted to deliver the proposed Centennial Library and Archives redevelopment to the funding application stage. This contract was supported by funding from the New Zealand Libraries Partnership Programme, with the Wairoa District Council Economic Development Committee nominated as the project governance group.

#### 1. Project Plan

The current funding project supports the intent of Council to realise the Centennial Library and Archive Redevelopment Project Plan adopted by Council (2020);

To create a landmark community and cultural facility that improves public access to information, literature, heritage and cultural resources managed by Council; where building, greenspace and riverfront combine seamlessly to create a treasured public space.

"The redeveloped Library Archive stands at the heart of Wairoa on land that was once part of Manukanui Pā. True to this kaupapa it is a place that draws us to experience, share, engage and treasure language, knowledge, heritage and culture in a vibrant, accessible and welcoming space."

#### 2. Mana Whenua

A third mana whenua workshop in January was well attended. There is strong endorsement for the direction of the Manukanui development with engaging discussion by those in attendance. A subsequent presentation for mana whenua with RTA, Sandy Adsett will be held on 9 February in Wairoa.

#### 3. Design

The design brief draws on the heritage of the site as land that was part of Manukanui Pā, the Cultural and Heritage Impact Assessment *Te Rauwa*, and the commitment from Council to address real and raw socioeconomic needs identified in the 2019 community study *Whakarauora*. These influences, and the community's aspirations for the new centre, are captured in the project plan adopted by Council in 2020.

Concept design is informed by the project plan, detailed analysis of functional expectations and aspirations for the working spaces and bounded by an achievable build budget. Significant time is dedicated to exploring the floor experience and flow of operations inside the building with staff.

There is clear support from mana whenua for the shared vision to see Manukanui as a vibrant and welcoming celebration of Wairoa's people and place, and confidence that this will be successful through the creative collaboration between RTA and Sandy Adsett.

## 4. Funding

Applications have been successful to fund both architectural fees and engagement fees for Sandy Adsett for the preliminary design stage (total \$95,000). Capital funding will require Council approval. Council has committed \$1.9M to capital costs. Preliminary design presentation to governance is anticipated in March, with the opportunity to begin capital funding applications from June pending approval from Council.

#### 5. Internal Council Support and consenting

This is a council project with WDC representing both the applicant and consenting authority. The project team is working across Council departments concurrent to the design process to ensure a smooth consent process which is critical to external funding.

#### 6. Covid 19

At the writing of this report, disruption due to Covid restrictions is minimal. Most working meetings are progressing remotely. Meeting with mana whenua have been successfully accommodated in the War Memorial Hall, the latest scheduled for Wednesday 9 February.

## 2. OPERATIONAL UPDATE FOR MONTHS OF NOVEMBER AND DECEMBER 2022

Since opening a year ago, Wairoa's Digital Hub has upskilled and provided technology access to around 3,500 people. Based in the Wairoa Library, the Digital Hub is fast becoming a public go-to for people wanting to access technology and build their digital confidence.

The aim of the hub is to provide another local component to improve the district's connectivity and digital capability by offering community courses, 13 computers available for public use and a technology hub manager on hand to assist. Through the initiative, people are able to improve connectivity by breaking down barriers including access to affordable broadband. Technology is growing at a rapid pace and the Digital Hub is a base for people to be able to keep up no matter whether it is a smartphone, tablet or computer.

There has always been a real appetite for better digital access in Wairoa and this initiative complements a number of other digitally-based projects in the district. The hub is a great example of how Central Government external funding, in this case through the PGF fund, can be transformative for rural areas

During November and December, the Digital Hub team provided support with activities including formatting assignments, online applications, email access, printing and general computer assistance. Through these months, the team ran coding classes for children. After school coding classes held on Mondays and Wednesdays have been popular. All positions were filled and more have been added to the waiting list ready for the next term.

The Digital Hub team supported the Library's initiative to print vaccine passes for those in the community. At one stage, the Hub and Library was the only spot in town offering this service. Due to the volume of people requiring assistance, a booking system was put in place and staff added to this every 30 mins.

Many of the 220 families that were supported did not have email accounts or access to computers, so providing a place in which they could receive this support was a relief for them. The team received many positive and appreciative comments from people who were thankful for the service provided. Many said that "it would have been impossible for them to do it alone".

## 1. PURPOSE

1.1 This report provides information for Committee on Economic Development Activities. No decisions are required by Committee at this stage.

## RECOMMENDATION

## 2. SUSTAINABLE FOOD AND FIBRES

- 2.1 Central Hawkes Bay District Council submitted the application to the SFF Futures fund for the almonds feasibility study on behalf of key stakeholders including WDC. The application was successful.
- 2.2 A project brief is currently being completed and will be distributed to all stakeholders.

#### 3. BANKING

- 3.1 Wairoa Kiwibank (located in Hammer Hardware) is still offering services as a physical bank premise. Including some services for non-Kiwibank customers and to sign new customers up instore. For Kiwibank customers, the services that are available include cash deposit and withdrawals.
- 3.2 Members from the ED and Finance teams met with the BNZ to understand different types of support that Wairoa could receive following the departure of BNZ from the district.
- 3.3 BNZ have advised that they have not had complaints from Wairoa customers about not having a physical branch in the district. Council officers advised that this was contrary to conversations on the ground and that many officers had experienced in the community.
- 3.4 BNZ will provide a list of functions that require customers to physically enter a branch, as well as looking into options for these services to be offered as required in Wairoa. BNZ also advised that they would be interested in offering support and training in Wairoa, working with the Digital Hub.
- 3.5 We are open to discussions with other banks about how people in Wairoa can be best supported.

## 4. CHRISTMAS

- 4.1 Grabbing a Selfie with Elfie was a huge hit with young shoppers on Saturday 23 December.
- 4.2 The tautoko Wairoa shop local promotion had tamariki tearing around town in search of the elusive Elfie who kept popping up in the most obscure places.
- 4.3 The competition saw Elfie hiding in local businesses, and once discovered tamariki aged between 0-16 could take a selfie with Elfie and tag Wairoa District Council on Facebook.
- 4.4 The pre-Christmas game proved to be a popular pastime with loads of parents and adults supporting their tamariki to take part.

## 5. TE MAHERE WHAI MAHI MĀORI – MĀORI EMPLOYMENT ACTION PLAN

- 5.1 Central government is launching Te Whai Mahi which underlines a commitment to supporting kaupapa Māori and working kanohi ki te kanohi and in partnership with whānau, hapū, iwi and wider hapori to improve employment outcomes for Māori.
- 5.2 This is a cross-government action plan that supports the mahi already underway across government to support inherent mana in Māori communities. Te Whai Mahi Māori aims to address disparities, remove barriers, create opportunities and foster pathways into equitable and fulfilling careers.
- 5.3 This online launch will be attended by the ED officer to understand how the action plan could deliver for Wairoa.

## 6. MTFJ

- 6.1 The MTFJ contract continues to be delivered by the Wairoa Young Achievers Trust, with 46 rangatahi engaged in sustainable employment since June 21.
- 6.2 Wairoa has been selected as a pilot council for a partnership with Outward Bound. MTFJ is working with Outward Bound to assist with their Impact Lab report looking into the benefits of Outward Bound into a young person's life and employment journey. The idea is for this to be a 50/50 partnership between Outward Bound and the five selected pilot councils, with the council utilising the MTFJ Community Recovery Funds.
- 6.3 Once the Impact Lab study is completed, MTFJ is looking to help Outward Bound to bring the results forward to central government for further investment for NEETs to access Outward Bound courses.




## 2. INTERCITY BUS
