#### BACKGROUND

1.4 Section 66 of the Iwi and Hapū of Te Rohe o Te Wairoa Claims Settlement Bill 2016 specifies the requirements of the Reserves Act 1977 which are applicable to the Board. This section states the below when appointing a Chairperson and Deputy Chairperson:

An appointer may appoint 1 of the members of the joint board as chairperson and the other appointer may appoint 1 of the members as deputy chairperson of the joint board as follows (despite section 32(5) and (6) of that Act):

- (i) The initial chairperson must be appointed by the Council.
- (ii) The initial deputy chairperson must be appointed by the trustees.

- (iii) Each appointer holds that right of appointment for the term of the board and at the close of the board's term, each right shifts to the other appointer for the duration of the subsequent term.
- (iv) An appointment takes effect on the commencement of the board's term (or for the initial chairperson and deputy chairperson and any replacement appointment under subparagraph (vii) on the date stated in the notice of appointment.
- (v) An appointment ends on the expiry of the board's term (or if earlier on the replacement of the person holding the relevant office by the relevant appointer or at the end of his or her appointment as a member under section 64 of this Act).
- (vi) The right of appointment may be exercised only by giving written notice of the appointment to the other appointer and the member concerned.
- (vii) An appointer may replace the chairperson or deputy chairperson appointed by that appointer at any time during the relevant board's term:

(c) If the chairperson is not present at a meeting, the deputy chairperson must preside at the meeting (despite sections 32(5) and (6) of the Reserves Act 1977):


## Monthly Report for Wairoa - Mohaka – March 2024 Nathan Heath – Māori Relationship Manager (Northern Hawke's Bay)

Wairoa HBRC activity report for March 2024.

#### 1) HBRC update – including issues and Council & Committee meeting items of local relevance.

- HBRC Te Pou Whakarae I am delighted to report that Te Wairama Munro has been appointed as the new Te Pou Whakarae for HBRC. Te Wairama's whakapapa includes Ngāti Rakaipaaka, Ngāti Hine, Ngāti Hinepua, Ngai Te Ipu, Ngāti Kahungunu ki Te Wairoa, and Ngāti Kirihika. As my new boss, I have had the pleasure of working with Wai over the last few years and she brings a huge skill set and the mana to carry on the important work for the region initiated by her Uncle Pieri Munro. We wish Te Wairama all the best in her new role. A pōhiri for Te Wairama will be held at 12pm 16 April at Kahungunu Marae in Nuhaka.
- Long Term Plan Community consultation for the 3 year HBRC Long Term Plan, begins next month. Drop is sessions with HBRC Councillors are being organised for Tuesday 16<sup>th</sup> April, 4:30-6:30pm at Wairoa New World and Thursday 18<sup>th</sup> of April 1:00-3pm at the Wairoa Community Centre.
- Regional Land Transport Plan is also open for consultation and submissions. This work is done on behalf of all the regions Local Government agencies and signals a huge body of work for the region to build back and enhance resilience into Hawkes Bay roading infrastructure. - The Independent Review into the Hawke's Bay Civil Defence Emergency Management Response into Cyclone Gabrielle was released on Monday 25 March. - Earlier this month NIWA released a report of the flood flows during Cyclone Gabrielle for Hawkes Bay. Modelling has estimated that the Wairoa River at Marumaru peaked at 4,100m<sup>3</sup>/sec. This is compared to previous flows in the graphic below. #### 2) Wairoa District Update.

- I would just like to acknowledge Benita Tahuri who has just finished her 12 month role as the Recovery Manager for Wairoa. I have worked a lot with Benita over this period and she took her role deeply to heart and never wavered from the mission of getting whānau back into their homes.
- Work will commence on the construction of a weir in the Rāhui Channel at Whakakī on 8 April. The weir is being constructed to improve the ability of the community to manage Whakakī lake levels to protect mahinga kai and prevent the flooding of whenua and whānau. This is significant milestone for the Whakakī Freshwater Improvement Fund project between the Whakakī Lake Trust, marae, whānau, landowners, HBRC, MfE, DoC, Fish & Game and others.
- Nuhaka & Whakakī update. There has been a delay in the work of developing flood protection options for Nuhaka until May. Once these are completed, they will be discussed with the community. Additional improvements are being made to the Ramarama culvert at Whakakī and HBRC engineers have met with members of Ngāti Rakaipaaka and the community to discuss flooding issues of the wetland in town.
- Mohaka Plan Change the Mohaka me Waihua Freshwater Plan project team on behalf of the tangata whenua collective of iwi Māori entities of the Mohaka and Waihua catchments met with the HBRC Mohaka Plan change project team earlier this month. Phase 1 of the work is now completed. Project teams are successfully working together to navigate a pathway forward so that the work can maintain it's momentum while acknowledging that there will be changes to the National Policy Statement for Freshwater Management in the next few years.
- Work is continuing at pace with the districts woody debris clean up. Work is now completed at Mahia and Opoutama and is now continuing between Blacks Beach/Te Ureti and Nuhaka, Whakamahi to Waihua and Mohaka to Waikari.

#### PURPOSE

This report is for the Board to consider the Wairoa River Reserve Restoration project. No decisions are required by the Board at this stage.

#### RECOMMENDATION

The Pouwhakarae-Hua Pumau | Group Manager Assets & Infrastructure RECOMMENDS that the Board receive the report.

#### BACKGROUND

- 1.1. In February 2023, Cyclone Gabrielle caused significant damage to Wairoa's reserves, particularly along the banks of the Wairoa River. Floodwaters crossed Marine Parade in some places, surpassing levels of seen during Cyclone Bola.
- 1.2. In September 2023, Wairoa District Council (WDC) were granted \$1.5m funding from Kanoa (Regional Development & Investment Unit) to restore the Wairoa River reserve along Marine Parade focussing on the area west of the Wairoa Lighthouse towards Locke Street, linking to the new Wairoa iSite being built at the corner of Locke Street and Marine Parade.

#### 2. CONCEPT DESIGN

2.1. A concept design was brought to Council in December 2023. Some changes were requested. The updated concept design is included in Appendix 1.

The design focuses on the area west of the lighthouse, including links to and enhancement of the new iSite and Ahi Kōmau (Gemmell's on Parade). A new wharf will be included in the design, however it is unlikely there will be funding remaining for its construction.

Council reviewed the concept design on 13<sup>th</sup> February 2024, and endorsed that the project move to a detailed design phase, provided that the Matangirau Reserves Board are also satisfied with the concept.

#### 3. BUDGET AND DELIVERY



#### BACKGROUND

The 2021 Wairoa Town Centre Masterplan, developed by WSP, identified the Marine Parade Central Business Precinct as an area of local significance due to the presence of retail / commercial frontage. One of the masterplan's goals was to create opportunities to further enhance this area and to increase foot traffic as well to entice a greater number of visitors, and to encourage them to spend more time in the area.

To achieve this aspiration, this section of the town centre's masterplan intentionally incorporated keyenhancements at arrival and destination points to promote movement. This also included substantial amenity improvements as well as improved connectivity to the river frontage.

# MARINE PARADE RIVERFRONT CONCEPT

The Marine Parade Riverfront Upgrade will be developed in two stages. Stage 1 includes the Stage Amphitheatre and Picnic Lawn. Stage 2, which involves the Wharf and Jetty extension, is not part of the current proposal and will be developed in the future.

Stage 1 is essentially an extension of the town centre masterplan with a more detailed focus on the Marine Parade river frontage section. Most notably, the concept addresses the following:

- Enhancing visual and physical pedestrian connections between the Wairoa River frontage, including river access, and Marine Parade. This aims to improve amenity and usability for local residents and enhance the area's appeal to visitors.
- Upgrading riverside facilities that are conveniently situated and compatible with retail and food activities.
- Providing opportunities for visual attractions (e.g., art, lighting, informative signage) strategically positioned to entice visitors to explore the length of Marine Parade, thereby increasing foot traffic and the average dwell time. The attractions also help anchor the western and eastern extents of the town centre.
- Creating open areas to allow events and activities, such as cultural events, festivals, or night markets, in collaboration with adjacent spaces such as the riverfront and Marine Parade plazas.
- Preserving and enhancing existing landmarks, such as the lighthouse.
- · Identifying opportunities to include heritage or themed 'promenade walks' along the riverbank to complement the town centre frontages.

#### **STAGE 1: DESIGN PHILOSOPHY**

The design philosophy for Stage 1 centres around creating a harmonious blend of nature and culture. We believe the new amphitheatre and picnic area can serve as a focal point for community interaction and to encourage people to stop and enjoy Wairoa, connect with each other while having the sense of being close to nature.

The design seamlessly integrates with the surrounding environment, using locally-sourced materials and native landscaping. The seating area features a combination of concrete benches and grassy terraces to offer a natural and comfortable amphitheatre experience.

The amphitheatre will reflect the unique character of Marine Parade and the Wairoa River, promoting cultural appreciation, and a sense of belonging within the community.


In terms of resilience, the concept accommodates robust design elements that includes movable furniture and infrastructure, such as picnic tables and shade sail structures that can be easily replaced if damaged or temporarily removed in the event of an extreme weather event. All materials and furniture will be durable and flood-resistant, designed to withstand contact with floodwaters without significant damage.

#### **Spatial Arrangement**

Spatially, the concept comprises three distinct areas:

- 1. Amphitheatre and Performance Stage
- 2. Riverside Walk
- 3. Picnic Lawn and Native Garden
- 4. Riverside Connection

These areas are complemented by existing site features, including the lighthouse, rock garden, interpretive signage, mature pohutukawa trees, and planted beds.

#### Amphitheatre

The new amphitheatre will be a permanent, multi-use outdoor venue intended for community events. It is positioned approximately 4 meters from the edge of the Lighthouse rock garden to align with the site's topography's slight elevation. The curved shape of the new amphitheatre follows the natural 'bowl' contours of the location.

The seating risers are designed to offer informal seating for daily gatherings of locals and visitors, as well as for community events such as Christmas performances and local concerts. Users of the space will enjoy both sunny and shaded seating options with clear views of the performance stage and the Wairoa River in the background.

The area includes a performance stage raised approximately 0.5 meters above the existing ground surface to improve visibility from the amphitheatre to the stage. A durable concrete pad is proposed due to the low-lying nature of the area and potential transportation of equipment for performances.

The two-tiered seating risers consist of curved concrete block retaining walls and grass seats. To facilitate lawn maintenance, they have been designed approximately half a meter deep to accommodate lawn mowers. The amphitheatre can be accessed from a 4-meter-wide concrete shared path at the top of the terraces and a 1.5-meter-wide concrete pathway at the bottom of the amphitheatre. Low concrete block walls define the edge between the shared path and the upper part of the amphitheatre, promoting pedestrian movement and legibility. The concrete blocks serve a dual purpose, providing informal seating opportunities and vertical faces that can feature bespoke laser-cut steel patterns showcasing cultural art to enrich the outdoor environment and celebrate local identity.

Two flights of stairs and landings provide access between the upper and lower terraces of the amphitheatre. The upper terrace will be flush with the shared path to ensure accessibility for individuals of all abilities in the Wairoa community.

A cantilevered timber shade structure will support canvas sheets/ shade sails to create a shaded outdoor space for the amphitheatre during the summer. For durability, longevity and comfort, the shade sails can be removed during the winter months. There is also an opportunity to attach changeable, coloured banners to the timber posts.

#### **Riverside Walk**

A 4-metre-wide concrete shared walk-cycleway is proposed along the riverfront. New access points are located along the pathway to create direct pedestrian connections to the picnic lawn and will provide access to the amphitheatre. It provides opportunities to recognise and enhance human and natural heritage, improve amenity, and contributes to the legibility of the town centre and Marine Parade. The concept design incorporates public art installations and interpretive signage in spaces along the pathway where pedestrians are encouraged to spend more time to learn and explore about local heritage.

Patterns etched into the concrete footpath surface are proposed at the two pedestrian crossings to highlight these thresholds and reference the cultural identity of the river. An amenity and heritage feature such as a large public art installation is proposed at the gateway connector pedestrian crossing.

#### **Picnic Lawn and Riverside Connection**

In an effort to ensure the longevity and usability of the picnic tables, BBQ's and shade structures, a strategic decision has been made to locate them on higher ground. This location was chosen specifically to protect the furniture from potential damage during flood events. By situating the facilities on higher ground, the design can significantly reduce the risk of water damage and ensure that the picnic area remain functional and enjoyable.

In addition to this, the picnic tables, BBQs, and shade sails have been thoughtfully placed in proximity to the Pohutukawa trees. This arrangement caters to both group gatherings and individual meetings, offering options for shaded and sunny spots. The orientation of the picnic elements has been carefully planned to offer views of the river, creating a serene and picturesque environment. The facilities are buffered from Marine Parade by a planted strip and anchored by the large trees, further enhancing the sense of tranquility and connection with nature. This strategic placement not only ensures durability of the facilities but also enriches the user experience.

New compacted limeston path and riverside steps provide contact with the river. The ability for much greater active or passive interaction with the river is considered of great significance and value and also references the greater level of physical contact at this point of the river.

#### **Planting Palette**

A native garden bed is proposed between the concrete footpath and picnic lawn to soften the pathway and provide a natural backdrop to the lawn area. To maintain visual permeability into the picnic area and enable passive surveillance from Marine Parade, a range of low-growing native species is suggested. Decorative steps are arranged along the planted buffer strip to facilitate access from the Riverside Walk to the picnic lawn and picnic tables from the footpath.

A total of four new Pohutukawa trees are proposed for the project to replace the existing Pohutukawa trees in the future.

#### Furniture, Materials and Lighting

Furniture is an important public realm element for any public space. It provides the opportunity for the public to sit, linger and interact with each other and the environment.

The suite of materials and design elements have been selected to create a consistent feel throughout the site. It is intended that the overall design is minimalistic in order to avoid over complicated embellishments.

All furniture products suggested below are pending discussions and approvals from WDC. All furniture will be robust and well-designed to ensure comfort and ease of use. Furniture that can be easily replaced and is readily available will be selected.

Materials such as textured concrete, steel, wood, and boulders have been selected for their functionality, vernacular aesthetics, overall durability, and consistency with the Lighthouse setting.


Lighting including decorative lighting will be developed during the developed design and detailed design stages.







