#### 1. PURPOSE

- 1.1 The purpose of this report is to provide Council with a breakdown of the key themes and topics from the submissions received from the community throughout the formal consultation period for the Long-Term Plan (LTP) 2024-2027
- 1.2 This report has copies of the submissions to the LTP 2024-2027 for Council's consideration as part of the deliberations process.

#### RECOMMENDATION

The Acting Group Manager - Community Services and Development RECOMMENDS that Council:

- 1. Receive and consider all submissions made on the Long-Term Plan 2024-2027 Consultation Document.
- 2. Receive and consider all submissions in relation to "No Time to Waste."
- 3. Adopt the preferred option for Tautoko Wairoa | Buying Locally: Option 1 Maintain status quo OR Option 2 Purchase from local business on a case by case basis.
- 4. Adopt the preferred option for *Decision 1 Essential Repairs or Improvements to Our Land Transport Network*: Option 1 - Rectification + BAU OR Option 2 - Rectification + BAU + Targeted improvement.
- 5. Adopt the preferred option for *Decision 2 Solid waste management and minimisation*: Option 1 - Development of a New Landfill Cell OR Option 2 - Out of District Disposal.
- 6. Adopt the preferred option for *Decision 3 Kerbside Collection*: Option 1 Business as usual OR Option 2 Introduction of a new kerbside collection model including food waste and garden organic collections.
  - a. Adopt the preferred option of a fortnightly kerbside wheelie bin service for rubbish OR continue weekly user-pays rubbish bag.
  - b. Adopt the preferred option of introducing a weekly food and garden waste collection in Wairoa, Frasertown and Mahia OR introducing a food waste collection in Wairoa, Frasertown and Mahia.
  - c. Adopt the preferred option of introducing a fortnightly kerbside wheelie bin for recycling in Wairoa, Frasertown and Mahia OR maintaining a weekly kerbside recycling service (open bin).
- 7. Adopt the preferred option for *Decision 4 Breathing new life into Wairoa businesses*: Option 1 - No investment OR Option 2 - Annual Investment.

- 8. Adopt the preferred option for *Decision 5 Protecting Our Taonga The Future of Our Archives*: Option 1 - Keep the archives in Wairoa OR Option 2 - Move archives out of district.
- 9. Discuss and adopt any additional Council-initiated changes arising from Long-Term Plan 2024-2027 and No Time to Waste hearings.
- Instruct staff to prepare a Long-Term Plan 2024-2027 for adoption at Council's meeting on 8 August 2024, incorporating any amendments resulting from resolutions made during the Council deliberations process.
- 11. Note that the final content of the Long-Term Plan 2024-2027 is subject to minor corrections.

### 2. BACKGROUND

- 2.1 Due to the introduction of the Severe Weather Emergency Recovery Legislation Act 2023 (SWERL 2023), Wairoa District Council is producing an unaudited Three-Year LTP with a recovery focus, in place of the usual 10-Year Long Term Plan.
- 2.2 The Local Government Act 2002 (LGA 2002) requires Council use the special consultative procedure to consult with the community before adopting the final plan. This process involved the adoption of a Consultation Document (6 June 2024 Council meeting) which summarised Council's intentions over the course of the plan.
- 2.3 Consultation for the LTP 2024-2027 opened on 17 June 2024 and closed on 17 July 2024. The document asked the community to provide feedback on six big decisions each with two options, that clearly set out the impact on rates and council debt:
  - Tautoko Wairoa | Buying Locally
  - Decision 1 Essential Repairs or Improvements to Our Land Transport Network
  - Decision 2 Solid waste management and minimisation
  - Decision 3 Kerbside Collection
  - Decision 4 Breathing new life into Wairoa businesses
  - Decision 5 Protecting Our Taonga The Future of Our Archives

A supplementary consultation "No Time to Waste" ran co-currently, asking the community:

- Do you support Council's proposal to replace the current weekly user-pays rubbish bag service with a fortnightly kerbside wheelie bin service for rubbish?
- The proposal is to introduce a weekly food and garden waste collection in Wairoa, Frasertown and Mahia. Do you support the introduction of this service?
- If yes, what option should Council introduce: food only or combined food & garden;
- Do you support the proposal to replace the current weekly kerbside recycling service with a fortnightly kerbside wheelie bin for recycling in Wairoa, Frasertown and Mahia?

Links to the Council's draft Financial Strategy, Draft Infrastructure Strategy and Draft Fees and Charges, along with other relevant Policies and documents were included on the consultation website.

- 2.4 The consultation document for the plan was supported by community engagement sessions. Originally a number of community meetings and caravan sessions were scheduled, however due to the 26 June 2024 rain event and subsequent Civil Defence emergency response, only the 25 June community meeting at Wairoa War Memorial Hall went ahead. In order to engage with the community through the response period, facebook engagement was prioritised to promote interaction with the consultation document. The consultation documents and feedback forms were distributed to local stores around the district and a drop in session was held in Council Chambers on 15 July, with a phone-in option available.
- 2.5 Any member of the public could submit, either online or via a hard-copy form. Council received a total of 48 submissions for the LTP 2024-2027and a total of 43 submissions for No Time to Waste.
- 2.6 300 consultation documents were printed and distributed through the community. 60 radio advertisements ran across two local radio stations. Facebook posts relating to the LTP consultation had a reach of 32,900, with a reach of 9,800 for No Time to Waste posts. There were 1,267 webpage views for the LTP 2024-2027 consultation page, and 354 views for the No Time to Waste consultation page.
- 2.7 Attached to this report is the submissions received during this period. They are divided into two sections speaking (appendix 1) and non-speaking (appendix 2).
- 2.8 Once Council has received the submissions, the next step in the process is to begin deliberations on the final LTP 2024-2027.






# Long-Term plan submissions analysis

This report summarises the feedback received for each consultation item, along with other, more general feedback received through the submissions process. The consultation document details each topic and all submissions are included as an attachment to this report. In addition to single response tick-boxes, allowing respondents to select their preferred option for each consultation topic, submission forms also allowed free-text responses to provide additional comments related to the Long-Term Plan consultation. These responses were reviewed to identify key themes, concepts or issues within submitted feedback.

The LTP Consultation received 45 online submissions and 3 paper submissions. 7 responses were on behalf of a group or organisation (15%) and 9 respondents expressed their willingness to speak inperson in support of their submission (19%).







#### Tautoko Wairoa | Buying Locally

Respondents were presented with the below two options: Option 1 - Maintain status quo Option 2 - Purchase from local business on a case by case basis (preferred)

79% of respondents selected the preferred option 2.

Additional comments showed that, while there is strong support for buying locally to benefit the Wairoa community, there is also recognition of the need for responsible fiscal management and ensuring that all procurement decisions are made with the best interests of ratepayers in mind. Key themes from the respondents are as follows:

**Balancing Local Support with Financial Prudence:** There is a clear emphasis on balancing the desire to support local businesses with the need for financial efficiency. Respondents acknowledge that while supporting local businesses is important for community development and economic resilience, it should not come at the cost of overpaying when more cost-effective options are available through larger contracts or online purchasing. There is a consensus that local businesses should be supported when they can offer competitive value and quality but that there should be transparency in procurement decisions. Respondents suggest a flexible approach where local businesses are

prioritised when feasible and practical, especially when they can offer tailored solutions or services that meet the specific needs of the Council or community.

"There are sound reasons for the Council to purchase in bulk through already-in-place agreements and protocols. However, Council should make every effort to purchase locally wherever possible keeping ratepayer money within the community."

"Council should endeavour to source everything locally before looking outside Wairoa."

"If it unnecessarily increases costs for things that don't add value to Council services and activities (e.g., pens!), it is better to go for the lowest cost given all of the challenges our district faces and direct the funds elsewhere."

"Inappropriate at this juncture to be removing access to quality discounts at a time where fiscal restraint needs have never been more evident no matter how much we would love to tautoko local."

"WDC is to ensure this is covered competitively in Finance, Assurance & Risk committee policies and procedures."

"The purpose of council is not to support selected business by spending with them - its job is to support ALL business by providing services to the town which allow us to operate to the best of our abilities and grow."

"May I suggest a certain percentage can be set aside for mandatory support of local businesses - say 25% local purchase, 75% nationally sourced. Many local businesses simply can't compete financially, but I'd be perfectly ok with a smidge extra spent to support local. Without business incentives here, our town will die."

"In light of the recent flooding in Wairoa, which has compounded the ongoing recovery efforts from Cyclone Gabrielle, the Council must prioritise essential services and recovery. This includes getting the best bang for buck from All of Government contracts and the likes."

**Community and Economic Development:** Many responses highlight the importance of local procurement in stimulating the local economy and creating jobs within Wairoa. Supporting local businesses is seen as crucial for the town's economic success and resilience, particularly in the context of natural disasters like recent flooding and post-Cyclone Gabrielle recovery.

"Tautoko Wairoa / Shop Local should be on signs on each store and each & everyone of us should be reminded that every dollar we spend locally keeps our economy going. Every dollar spent out of town is a nail in the coffin of our businesses."

"Council would be supporting local business, helping to keep those business running, and keep them in our area."

**Environmental and Social Benefits:** Local procurement is viewed favourably due to potential environmental benefits, such as reduced carbon footprint from transportation, and social benefits like stronger community ties and reduced economic disparities within Wairoa.

"Supporting local businesses can lead to more job opportunities within the community."

"A sustainable township involves investing in the local business, local people in order to develop a resilient community. This should involve all of the community in order to create local pride in the township."

"Local suppliers are often more accessible, allowing for better communication and quality control."

"Local businesses are more likely to be accountable to the community and responsive to the council's needs and concerns."

"Where a local business can compete on value and/or associated service provided it is important to tautoko them as part of achieving the broader community outcomes."

#### Decision 1 - Essential Repairs or Improvements to Our Land Transport Network

Respondents were presented with the below two options: *Option 1 - Rectification + BAU Option 2 - Rectification + BAU + Targeted improvement* (preferred)

72% of respondents selected the preferred option 2.

Additional comments showed that the community was aware of the need to balance immediate recovery needs, fiscal responsibility, and long-term infrastructure planning. There is a clear desire for the Council to prioritise essential services and pursue funding opportunities that lessen the financial impact on ratepayers.

Several responses emphasise the urgent need to address local infrastructure issues and create comprehensive plans that consider community needs and safety. This includes concerns about the fragility of current road networks,



economic development implications, and the importance of securing funding through infrastructure funds or targeted tolls. Respondents also highlight the importance of community engagement and clear communication in infrastructure planning. This includes requests for clear communication and engagement with the community to improve public understanding and ensure that public feedback in decision-making processes regarding project prioritisation and funding allocation is informed and meaningful.

**Prioritising Basic Infrastructure and Recovery:** Respondents emphasise the need to prioritise basic infrastructure and recovery efforts, particularly in light of recent natural disasters such as floods and ongoing challenges like coastal erosion. Respondents express concern that current needs must be met before committing to new projects or expansions. Respondents advocate for prioritising essential services, ensuring proposed investments meet community expectations and seeking external funding sources to support infrastructure upgrade projects.

"Local infrastructure needs to be addressed and a decent plan created to address key areas - taking into account access for those still affected from previous weather events."

"You will have to improve to the road networks in order for this region to survive"

**Financial Prudence and Transparency:** There is a notable concern about financial prudence and transparency in Council spending. Respondents question the cost-effectiveness of proposed projects, with a call for clarity in understanding how funds are allocated and how projects align with available grants or subsidies.

"There is no AMP or draft Infrastructure Strategy available to inform choosing between the options as to what is meant by safety and resilience improvements and how this would be prioritised/ or where they are. Whilst I agree they are needed in principle, it is unclear how value add would be achieved across the network and what improvements would be the best "bang for buck" and how this would play out under this scenario. Suggest further work is needed in this space or made available to the public to enable trade-offs to be made."

"the costs far outweigh the collective economic base of most Wairoa ratepayers"

"Council should not be budgeting for and subsequently rating the local share for projects that are highly unlikely to receive co-funding from NZTA through the application of the GPS. The district has invested heavily over the last 9 years in levels of service to the urban and rural communities. I believe this should be scaled back this 3-year plan to reflect returning levels of service and allow the community to invest in other priorities."

**Future-Proofing and Resilience:** Despite concerns about immediate costs, there is also recognition of the need for long-term planning and investment in infrastructure resilience. Respondents highlight the importance of future-proofing the transport network against extreme weather events and ensuring sustainable development practices are upheld.


"Given the history of extreme weather events, investing in targeted improvements can make the transport network more resilient to future events, potentially saving costs and disruptions in the long run."

"Investing in improvements alongside rectification not only addresses current needs but also prepares the community for future challenges, aligning with sustainable development and resilience goals."

**Decision 2 - Solid waste management and minimisation** Respondents were presented with the below two options: *Option 1 - Development of a New Landfill Cell Option 2 - Out of District Disposal (preferred)* 

83% of respondents selected option 1. Over 50% of respondents also provided commentary to their answer.

The responses identify concern around balancing economic feasibility, environmental sustainability, and long-term resilience in waste management practices. There is a clear desire for the Council to explore innovative solutions, engage the community effectively, and prioritise local economic benefits while managing the district's waste effectively and responsibly.



Local Economic and Environmental Impact: There is a strong

emphasis on keeping waste management local to retain economic benefits within the district.

Respondents highlight the potential economic opportunities associated with managing waste locally, including job creation and local investment. Additionally, keeping waste management local is seen as beneficial for minimizing environmental impact, reducing road transport, and supporting sustainable practices such as waste minimisation and recycling.

"by keeping waste management local we have greater incentives as a community to strive for waste minimisation and reuse. And this option keeps investment in the District, so contributing to economic development and also reduces land transport of waste via road with added burden on the roading system.

"Disposal of Wairoa rubbish in another town/country is not a desirable choice. Wairoa needs to become more self sufficient and sustainable"

"Opening the new landfill cell is preferable as the district requires a functional landfill even in times of extreme weather when the roads north, south and west might all be shut."

"Utilizing external facilities provides flexibility and can mitigate risks associated with the long-term management of a local landfill, such as regulatory changes or unforeseen environmental impacts."

**Cost and Financial Prudence:** There is concern about the costs associated with both options (local vs. out-of-district disposal). Respondents express skepticism about the affordability of out-of-district disposal for local residents and advocate for solutions that are financially prudent in the long term.

"An out-of-district plan will be too costly for local residents who are already facing higher costs imposed for the local landfill"

"Further, our geography - with all those hills - makes the trucking of waste outside the district a terribly inefficent proposition. What, for example, would the figures look like if the fuel price suddenly doubled?"

"Keep local to try to minimize road usage and costs to rate payers."

"Exploring options with adjoining Councils on co-ownership would be worth investigating prior to defaulting to the out of district proposal.

The landfill operations are a business and employment opportunity and should be explored with a commercial and long term view."

**Innovation:** Many respondents stress the importance of long-term sustainability in waste management practices. Suggestions include exploring advanced technologies like waste-to-energy plants or methane capture to generate electricity. There is a clear desire for innovative solutions that reduce reliance on traditional landfill methods and promote environmental responsibility.

"Develop a new site and incorporate future technologies such as capturing the methane gas to power generators. This has already been done in Auckland"

"The prospective new cell should be the last cell ever required. In the long term all products which cannot be recycled or composted could be processed in a waste to energy plant as is already done overseas. These plants operate at high temperatures (thousands of degrees) and meet strict emissions standards, while generating electricity for their localities." "You have an opportunity to be innovative here and perhaps even create new job opportunities with new industry...There are recycling plants, waste-to-energy bio fuel plants etc that create their own electricity & biofuel etc (there are even small portable plants which may suit us). Fortune favours the brave and there is no reason why we can't be leaders in a field - even if it's rubbish disposal"

**Waste Minimisation Education and Behavioural Change:** There is recognition of the role of education in promoting waste reduction behaviours among residents. Respondents suggest initiatives to encourage recycling, reuse, and responsible consumption habits to reduce the overall volume of waste generated. There is concern about the environmental impact of landfill operations and the importance of adhering to best practices in waste disposal and management.

"Ultimately, everybody needs to create less waste which will be a great challenge that cannot be achieved by either option alone... Eventually, with all waste significantly minimized the cost will go down for people, which is true for both option 1 and 2."

"More recycling efforts encouraged. An Eco barn to store things that may be reused. Encourage people to come to the ecobarn/recycling center with their unwanted and collect for a small fee something they might want."

"as kaitiaki the focus must be on minimising waste, encouraging business to provide zero waste options and if that is impossible purchase responsibly"

"Out of District Disposal option is an environmental lie - it's called "Green Washing". It does not make you better "environmental performers" it is still your rubbish hiding in someone else's backyard. I would have liked to have read what ideas/solutions, if any, mana whenua or para kore have. Are they viable?"

"Teach people to recycle to reduce"


"The higher costs associated with out-of-district disposal can incentivize the community and local government to adopt more aggressive waste minimisation, recycling, and composting programs, aligning with broader sustainability goals."

**Decision 3 - Kerbside Collection** Option 1 - Business as usual *Option 2 - Introduction of a new kerbside collection model including food waste and garden organic collections (preferred)* 

62% of respondents selected option 2.

Overall, the responses reflect that the community is concerned about balancing environmental responsibility with economic feasibility in waste management decisions. There is a clear desire for solutions that encourage waste minimisation, promote community engagement, and maintain financial prudence while addressing the district's waste management needs effectively.

**User Pays vs. Rates Funding:** Concerns are raised about the cost-effectiveness and efficiency of proposed waste management solutions. Many respondents express concerns about the financial burden on ratepayers if the cost of waste management is included in rates. There is a preference among some for maintaining the user pays



model as it provides a direct incentive for waste reduction and recycling. Others argue for subsidizing or providing free services for certain demographics, such as pensioners. Respondents suggest enhancing existing transfer stations to handle food waste and green waste effectively, rather than investing heavily in new kerbside collection systems that may not align with community needs or behaviours.

"Not everyone uses the current kerbside collection so making them pay through the nose via rates is removing any and all incentive to live sustainably and work towards zero waste. ... This is a classic example of the appropriateness of User Pays not charge everyone for something that many won't use"

"The user pays system at least encourages people to recycle (because it costs them not to), and at the transfer station they are watched to a reasonable degree (and helped where needed) to put their recycling in the right bins, remove the bottle caps, etc etc."

"This will cost ratepayers more but with services such as these it should be on a user pays basis."

**Behavioural Change and Waste Minimisation:** Respondents advocate for solutions that reduce landfill waste, such as separating food and garden organic waste for composting. Several respondents highlight the importance of promoting behavioural change towards waste minimisation rather than simply providing more convenient waste disposal options like wheelie bins. There is concern that wheelie bins may encourage more waste generation and reduce the motivation for residents to minimize their waste. Suggestions include promoting home composting, providing subsidized compost bins, and investing in education about recycling and waste reduction.

"Easier ways to remove household rubbish is encouraged to reduce pests and eliminate the need for dangerous home burn offs"

"Ban food and organic waste in landfill with massive fines and the food waste/garden collection as a mitigation. Develop composting or other solutions to utilise this organic waste."

"Many regions are moving towards stricter waste management regulations, and adopting this model now can position Wairoa District ahead of potential future requirements."

"If this is more widespread across the district, then I would hope fly-tipping costs and costs for having the landfill open as often as it is would reduce."

"By any chance, can WDC make a collective effort with all local authorities to address waste management with major suppliers of their packaging of food and items to minimise waste across the country?"

**Community Engagement and Education:** Many respondents stress the importance of community engagement and education in improving waste management practices. Suggestions include educating households on recycling practices and promoting composting at home. Some respondents believe that improved education could be more effective in reducing waste than costly new kerbside collection schemes.


"It would be a better idea to educate the community on having their own composting system. Maybe, a discussion for the MSC, to reach out to marae to help educate whanau. Even involving Mens Shed, to build compost containers for homes - this would be a cheaper option for whanau."

"Most people have options to deal with green waste in house and it is a cheaper option. Effective education for householders about all recycling including green waste could be better than financing a new kerbside collection."

**Decision 4 - Breathing new life into Wairoa businesses** Option 1 - No investment Option 2 - Annual Investment (preferred)

64% of respondents selected option 2.

Overall, while there is support for enhancing Wairoa's business facades and town attractiveness, the responses indicate a cautious approach and emphasise the need for financial prudence and a focus on essential services and infrastructure resilience. There is a clear desire to balance aesthetic improvements with practical measures that ensure long-term economic sustainability and community wellbeing.



**Prioritisation of Essential Services and Recovery:** Many respondents emphasise the need to prioritise essential services and recovery efforts, especially in light of recent

flooding and other climate-related challenges. They argue that while town beautification and business facade improvements are desirable, they should not take precedence over critical infrastructure and services such as road repairs, stormwater management, and waste management.

"WDC needs to focus on core business of rebuilding better roading, building, resource management, telecommunication, civil defence management projects in the district. Without this, any business will regardless of how pretty they make their shops will suffer."

"the Council must prioritise essential services and recovery. Pursuing non-essential initiatives at this time is not feasible."

"Invest in public amenity, but not directly in privately owned buildings."

"Post cyclone our roads and infrastructure and waste management are a priority. This is a nice to have and should be a discussion but funded once our core services are back to BAU"

**Financial Concerns, Strategic Planning and Cost Management:** There is significant concern about the financial implications of investing in town beautification projects. Respondents worry about the impact on resident rates and believe that businesses should take more responsibility for maintaining their own facades. Suggestions include exploring alternative funding mechanisms such as optional loans recoverable via targeted rates or ensuring that any investment yields measurable economic benefits to justify the expenditure. Respondents advocate for an economic development strategy that aligns with business needs, tourism promotion, employment opportunities, and overall town improvement goals. There is frustration over perceived delays and lack of coordinated action in previous planning efforts.

"Keep business rates low to encourage businesses instead. If an annual investment is made it could be a contestable fund which pays for a improvements to facades after the approved and costed work is completed, but agreed in advance as an inventive. Similar to the Heritage New Zealand Heritage Fabric Protection Grants. "

"Although I agree with the outcome, I don't agree with the tool being proposed to achieve it. There is an opportunity to use this money in a more clever way to achieve the outcomes e.g. loan funding to help things happen with low interest. That would enable the money to be able to achieve much more than what could be with the same \$"

"I see little point in spending big dollars on a glittering town centre, only to see it covered in silt and all the doorways sandbagged every time it rains."

"Ensure public places infrastructure and maintenance. Promote local businesses."

**Support for Economic Development and Local Businesses:** There is strong support for initiatives that stimulate economic vitality and support local businesses. Respondents believe that improving the aesthetics of the main street and North Clyde could attract more visitors, shoppers, and new businesses to Wairoa. They emphasise the importance of creating an attractive environment that fosters community pride and engagement, which in turn could boost tourism and local spending.

"Breathing new life into wairoa businesses means - increased visitors, travelling public reasons to stop and enjoy, activities - a reason for people to stay and purchase from our businesses and yes pride in business buildings and upkeep"

"Businesses on both sides of the bridge are in dire need of revitalization and uplifting. Despite the climate events Wairoa is experiencing, to enhance the town, on both sides of the bridge, will encourage more respect and pride from the community. It may even encourage more traffic to call in for a cuppa rather than just drive through."

*"Improved lighting, footpaths and verandahs could really help the CBD beautification. A cohesive look will improve visitor experience."* 

**Enforcement of Bylaws and Responsibility:** There is a call for enforcing existing bylaws that require building owners to maintain their properties to a certain standard and to be held accountable for the upkeep of their buildings to prevent deterioration of the town's appearance.

"All Wairoa store owners should be aware of the bylaws associated with owning a building. It is essential that these bylaws are enforced otherwise there is no point in having them"

"Most retailers in town do their best to maintain ageing buildings but there are absentee landlords that need to be reminded of due diligence."

"Building owners need to be held responsible for the maintenance of their own buildings and understand the bylaw."

"Honestly at the moment i personally believe there are more important things to spend money on. It is up to each individual business building owner to keep their building looking clean and tidy, there is a bylaw that requires this. If all buildings were maintained to the bylaw level, our business area will look a lot more appealing."

#### Decision 5 - Protecting Our Taonga - The Future of Our Archives


Option 1 - Keep the archives in Wairoa (preferred) Option 2 - Move archives out of district

72% of respondents selected option 1.

Overall, respondents want to balancing the preservation of cultural heritage against practical considerations of access and cost, and ensuring the long-term security of Wairoa's historical records. Respondents prefer to maintain local access.

Local Accessibility and Cultural / Historical Significance:

Many respondents emphasise the importance of keeping archives locally accessible in Wairoa. They argue that local access fosters community engagement and strengthens connections to heritage and identity. The archives are viewed as more than just records—they are seen as taonga (treasures) that embody the history and culture of Wairoa.



Keeping them locally is seen as respecting their cultural significance and ensuring they remain integral to the community's heritage for future generations. Digitisation of records is seen as a viable alternative or complement to physical storage, potentially reducing the need for extensive local facilities while enhancing access. There is also support for collaborative approaches to leverage resources and expertise.

"Current documents need to be kept in Wairoa for ease of access. Historical documents can be digitised by the Knowledge Bank in Hastings for public access. The Knowledge Bank want to establish a presence in Wairoa and this would be a good opportunity to begin these discussions with some koha help for the Council. Knowledge Bank is a voluntary organisation with a huge array of equipment to do this task. The Wairoa Star has recently taken all its archive newspapers to them for digitising for public access. There is no need to reinvent the wheel when such services are already available."

"Once the records and information leave Wairoa, they will not be returning without a significant increase in the cost. The Wairoa Library would the most logical choice, as this is what has happened in other centres. The extension to the library would be my choice. "

"Accessibility for all (ramps, wide doorways, ground floor toilets)"

**Safety and Protection of Archives, Financial Considerations and Cost Efficiency:** There is significant concern about the costs associated with either keeping archives in Wairoa or moving them to a specialized facility outside the district. Respondents question the financial feasibility of building or upgrading local facilities versus utilizing existing resources like the Knowledge Bank in Hastings for digitization and storage. Some advocate for consolidating archives regionally if it proves to be a more financially viable and secure option. Concerns are raised about the physical safety and security of archives, particularly in the face of natural disasters like floods or fires. Some suggest that moving archives to a specialized facility outside Wairoa could offer better protection, but this needs to be balanced against the benefits of local accessibility and control.

"Attracting and retaining the skills in the region will be a constant challenge even with a better facility. Given the large scale of recovery work Council is faced with, this could be an opportunity to partner with neighbours or other councils to achieve a better outcome. Including looking at more ready access to taonga than what is outlined in the scenario as currently drafted."

"Keep records in the safest place. Protection outweighs all else. If this needs to be moved outside of Wairoa, I would prefer a consolidation of Hawkes Bay records - keep all Hawkes Bay records in the one place if this presents a financial compromise/benefit for all HB councils. That way, it is still considered & kept local."

"The management and protection of archives is a bespoke technical skill that is unlikely to be successfully resourced in Wairoa."

**Insufficient information:** There is concern from multiple respondents that insufficient information exists to make a decision. Requests for fully costed options in future consultation are made. "No costings? How do we make an informed decision without \$\$"

"It is not ideal to give options without any information to guide the decision making process."

"I find it hard to choose either option here without more context."

"There is no data to make an informed decision for Decision 5. Keep current documents in Wairoa for ease of access is preferred - but at what cost? Historical documents can be digitised by the Wairoa Museum or Knowledge Bank in Hastings for public access."

#### **Other feedback**

There were a variety of responses which demonstrated a community-driven desire for sustainable growth, enhanced resilience, and inclusive economic development that preserves and celebrates Wairoa's unique cultural identity and natural assets. The feedback highlighted a need for strategic planning, transparent governance, and community involvement to effectively address current challenges and capitalise on future opportunities.

**Infrastructure and Environmental Resilience:** There is a strong emphasis on enhancing infrastructure resilience, particularly in response to recent weather events like floods. Suggestions

include implementing long-term flood protection measures such as stop banks and dredging the river mouth, which are seen as critical investments to safeguard the town and encourage economic stability.

**Community Engagement and Transparency:** Many respondents highlight the importance of community engagement in decision-making processes. They advocate for transparency in how decisions are made and how funds are allocated, particularly concerning rates increases and the prioritisation of projects. There is a call for more robust consultation to ensure that community needs and preferences are adequately addressed.

**Economic Diversification and Tourism Promotion:** There is a consensus on the need to diversify the local economy and promote tourism. Ideas include developing attractions such as Railbike Adventures, creating cultural and heritage tours, and hosting festivals and events (like a Māori food festival or storytelling festival). There is also support for enhancing existing facilities like the Nūhaka Domain to attract visitors and improve local amenities.

**Financial Management and Prioritisation:** Concerns are raised about the financial implications of proposed projects and plans. There is a desire for fiscal responsibility and prioritisation of essential services and infrastructure upgrades over non-essential initiatives. Some respondents express frustration with perceived misallocation of resources and call for a more strategic approach to budgeting and expenditure.

**Sustainable Development and Innovation:** Respondents advocate for sustainable practices and innovation in infrastructure development. This includes smart regulations on urban planning, waste management, and energy efficiency to reduce environmental impact and enhance community resilience. There is also support for exploring renewable energy options and promoting local sustainability initiatives.

**Historical and Cultural Preservation:** Several respondents emphasise the importance of celebrating Wairoa's cultural heritage and promoting local history. Suggestions include revitalizing historical sites like Pilot Hill, creating public displays honouring local figures, and improving the readability and accessibility of cultural heritage plaques and landmarks.


**Practical Solutions and Collaboration:** Practical solutions such as seeking external funding through grants and partnerships, particularly for disaster recovery and infrastructure projects, are recommended. There is also support for collaborating with neighbouring Council s, government agencies, and community organisations to leverage resources and expertise.

# No Time to Waste submissions analysis


This report summarises the feedback received for each consultation item, along with other, more general feedback received through the submissions process. The consultation had single response tick-boxes, allowing respondents to select their preferred option for each consultation topic, but also allowed free-text responses to provide additional comments related to the consultation. These responses were reviewed to identify key themes, concepts or issues within submitted feedback.

The No Time to Waste consultation received 43 online submissions. All responses were individual (not on behalf of a group or organisation). 3 respondents expressed their willingness to speak inperson in support of their submission (7%). The submissions showed a clear preference in all questions.

Although 62% of submitters were located in the Wairoa township, responses were received from across the district. There were three submissions that did not state their location.



Overall the key themes across all comments were as follows:

#### Cost Concerns and User Pays Preference with Opt-in Flexibility and Customization: Many

respondents are concerned about the potential cost implications of the proposed changes. There is a strong preference for a user pays system rather than funding through rates, with concerns about fairness and the financial burden on households, especially those producing minimal waste. Respondents consistently express a desire for flexibility and customisation in the service. There is a preference for an opt-in rather than compulsory system, giving individuals more control over whether to participate.

"I would expect that user pays means each bin is allocated and coded - user pays only if [wheelie] bin is put out."

"User pays only- a no brainer"

"Ensure this is a user pays system! I should not be funding the removal and processing of someone else's rubbish be it green or otherwise through my rates!"

"I would support this idea if it was optional but I am absolutely against making this compulsory and part of the rates fees."

"I support it in an opt in basis only and households should have the option of different sized bins and different pick up frequencies to meet their needs. I currently share a wheelie bin service with my neighbour and eve then we often don't have enough waste to justify a weekly pick up."

"We compost and have chickens so are there opt out options for un-necessary bins with reduced prices for opting out"

"Some of us produce very little rubbish so these initiatives would punish those of us who only buy soft plastic recyclables and send it away for recycling. I purposefully seek out and use products that require almost zero waste for kerbside collection. This initiative being loaded on to already very high rates would punish others who try as hard as I do to be zero waste"

"We only fill a bag every 3 weeks and compost all our food scrap. So that is a NO for me."

"We have nil waste. We compost all food scraps which is very minimal anyway. Recycle.... We should not be paying for others when we make an effort to be pro active!!

**Support for Recycling and Sustainability:** Despite concerns about costs and logistics, there is widespread support for improving recycling and waste management practices. Respondents value initiatives that promote recycling, composting, and reducing landfill waste. There is also interest in incentivizing good environmental practices through credits or rewards for recycling correctly.

"I would actually prefer you give people compost bins first and help them grow their own food using their compost."

"If you are collecting food and garden waste to make compost then allow the community to earn credits for buying the compost, or credits to earn garden boxes, seeds etc... Involve kura and schools, run events, have competitions."

"Keen az for this as a home owner, I'm all about recycling and doing the right thing"

"We need to incentivise good tikanga taiao"

"The Council used to have a shredder at the dump and we could buy the shredded green waste to put on our gardens. It would be great if this could be done again."

"Is the green and kitchen waste going to be composted or simply dumped. I would support a composting system."

**Community-Specific Needs and Logistics:** Specific community needs and logistical considerations are highlighted, such as the inclusion of remote areas like Nūhaka, and the logistical challenges faced by residents with long driveways or rural settings. There is also a call for clear communication about how the changes will be implemented and what options are available to residents in different areas.

*"Here in Nuhaka we have to take it to a collection point, it would be nice to have bins that are collected at our gate."* 

"We would love to have our rubbish collected from Awamate Road!! As a mum of 3 under 3, I can never get to the landfill and we have our own wheelie bins but this would make my life a lot easier. It's says Frasertown as a collection point and my address states Frasertown, however they won't collect my rubbish."

Native riparian plant species are most effective at maintaining river bank stability, whilst also contributing to biodiversity and local distinctiveness. Weed control and staged native planting of new areas of the river bank or council reserves as part of a long term programme would contribute to the stated strategic direction 'environmental wellbeing of the district now and in the future' and the outcome He Oranga Taiao – a protected, restored and connected environment. Some work could be done with the help pf community partners, such as the Ngahere Community Nursery and the Wairoa Awa Restoration Trust.
	Sustainable land use in the wider river catchment should be encouraged by policy development to limit conversion to forestry on erosion prone land and ensuring rules are in place for very careful harvesting of existing exotic forestry in order to minimise silt and slash entering the river.
	Funding should be directed to achieve these aims. And a percentage of the \$1.5M secured through Kānoa – regional investment for Wairoa riverbank restoration should be spent on retiring and restoring land for flood protection to act as a 'green sponge' with water retention and biodiversity benefits.



	From the outside looking in, staff numbers in some areas are disproportionate to the LOS, workload and outcomes being achieved. Diverting existing FTE to other priorities would be beneficial to achieve outcomes with little change to the total FTEs employed. Innovation and a focus on ways of working differently need to underpin continuous improvement, WDC is a small council with an incredibly large work programme and I cannot see through the CD how realistic it will be to achieve based on the status quo resourcing and tools available.

I also hope that some reflection and rethinking is done around the June flood and the additional recovery demands needed to inform the final Three Year Plan, Financial Strategy, and Infrastructure Strategy.
