#### 8.1 HBRC MĀORI RELATIONSHIP MANAGER REPORT

#### **COMMITTEE RESOLUTION 2024/41**

The Kaiurungi Kaupapa Here me Mana Ārahi | Policy and Governance Officer RECOMMENDS that the Board receive the report.

The Māori Relationship Manager introduced the report and highlighted the following:

- Hawkes Bay Regional Council voted to retain Māori constituency seats.
- There is a need to improve communication with communities affected by Cyclone Gabrielle and the June 26 floods regarding the Council's Rate Remission Policy.
- Bathymetric surveys of the Wairoa River have been completed, measuring the depth of the river channel.
- The Shorebird Survey, repeated in 2022 and 2023, shows significant impacts on threatened bird species. Cr Eaglesome-Karekare suggested receiving recommendations for mitigation in the Wairoa District. A plan to educate Mahia locals, such as involving schools in kaitiakitanga (guardianship) of endangered species areas, was proposed.
- Bird flu is a concern, with the Ministry for Primary Industries as the lead agency. Mr. Tong
  advised looking for signs such as more than three dead birds in one location. It was
  suggested to release communications on the concern on the Wairoa District Council social
  platforms.

Cr Thomas introduced the report, highlighting key points:

The Wairoa Water Ski Club has repeatedly lost its boat ramp due to flooding.

#### TE ROHE O TE WAIROA RESERVES BOARD - MATANGIRAU MEETING MINUTES3 SEPTEMBER 2024

• Water is now trapped in the area, and the club seeks to remove silt and debris.

Mr. McGregor outlined the club's goals:

- Improve the river's natural flushing.
- Straighten the river's corner to reduce water flow by the ferry.

Around 2,000 cubic meters of silt and debris need to be removed, potentially onto the reserve to raise the area. Work is expected to begin in 3-4 weeks, after the white baiting season.

Ms. McIlroy emphasized the need for cultural considerations, both historical and future. Mr. Beattie requested further discussions.

A meeting with mana whenua is scheduled for Friday, 06/09/2024, at 11 a.m., and a follow-up report will be presented at the next meeting.

The Meeting closed at 11am with a closing karakia given by Duane Culshaw.
