PURPOSE

1.1 This report provides a high-level summary for Committee members of a final draft of the Wairoa Economic Development Plan 2025.

RECOMMENDATION

The Kaiwhakahaere Hapori me te Whakapāpā | Community and Engagement Manager RECOMMENDS that Committee receives the report.

BACKGROUND

- 1.2 In October 2023, a report was presented to this Committee recommending the development of a five-year Wairoa District Economic Development Plan.
- 1.3 The aim was to gain support for a locally driven approach to supporting economic growth and building resilience from the ground up, reflecting the needs, ideas, and aspirations of our community.
- 1.4 In early April 2025, APR Consultants delivered two draft reports (the plan) for the Committee and Council's review and consideration: a 35-page summary report and a full 169-page report.
- 1.5 The main difference between the two is that the full report includes all the supporting data and references to other relevant work and strategies that inform the economic development plan for the district. See attachment 1.
- 1.6 The summary report highlights the key actions and presents condensed data specific to the Wairoa District. See attachment 2.

2. ALIGNING WITH COUNCIL'S VISION

- 2.1 The reports directly support Wairoa District Council's vision of building a vibrant, resilient, and connected Wairoa community.
- 2.2 By setting out clear actions and priorities, the plan contributes to Council's long-term outcomes of sustainable economic growth, improved well-being, and inclusive development.

- 2.3 It aligns with Council's goal by focusing on strengthening infrastructure, creating quality jobs, supporting local businesses, and ensuring that all parts of the community have opportunities to thrive.
- 2.4 Through this plan, Council can take a more strategic and coordinated approach to achieving its vision for the district.

3. SUMMARY OF THE PLAN

- 3.1 The draft reports (the plan) lay out a range of ideas to help Wairoa become stronger economically, socially, and environmentally.
- 3.2 They look at how to deal with current issues like the impact of severe weather events and focus on how to build a better future.
- 3.3 A key focus is on improving infrastructure and transport, especially upgrading key routes like State Highway 2, to support local business growth and attract outside investment.
- 3.4 The plan also addresses issues around jobs and industry, noting the need to retain skilled workers and reduce reliance on just a few sectors by diversifying the local economy. Industries like horticulture hold strong potential, but face barriers like geographic isolation and skills shortages.
- 3.5 The plan encourages support for these sectors and a shift away from the "Fortress Wairoa" mindset to enable better regional connection and collaboration.
- 3.6 Promotion of Wairoa is another key theme, with the goal of attracting visitors and new residents. The plan also looks at tackling demographic issues, such as an ageing population and rural-to-urban migration. Aligning local efforts with wider regional projects is also seen as essential, along with securing external funding to make things happen.
- 3.7 In tourism, the plan recognises the need for stronger coordination, better funding, and targeted marketing to help the sector grow.
- 3.8 In health, employment, and education, it backs initiatives that improve job readiness, expand training options, and ensure funding decisions are based on sound evidence.
- 3.9 Several sector-specific projects are included, such as developing cold storage for horticulture, supporting new crop types, expanding local wood processing, and growing Wairoa-branded food products.
- 3.10 Collaboration across sectors and regions is encouraged, with ideas like a Special Economic Zone and more local apprenticeships aimed at boosting long-term skills and investment.
- 3.11 Finally, the plan highlights housing as a priority and emphasises the importance of working closely with Māori communities, ensuring cultural values are respected and reflected in future development.
