#### 8 GENERAL ITEMS

#### 8.1 PLANNING AND REGULATORY REPORT - JULY UPDATE 2025

#### **COMMITTEE RESOLUTION 2025/141**

The Committee receives the report titled 'Planning and Regulatory Report 2025 – July Update'.

**CARRIED** 

The Group Manager – Planning and Regulatory introduced the report, noting recent amendments to the Local Government Official Information and Meetings Act 1987 (LGOIMA) relating to Land Information Memorandum (LIM) reports. A template for LIMs is being developed, with the key change from 1 July relating to the inclusion of the Climate Change Risk Report.

She also acknowledged recent dog attacks, highlighting the impact on the community and reinforcing the responsibility of dog owners.

The Compliance and Licensing Manager provided a brief update on three recent dog-related incidents, including two serious attacks that resulted in hospitalisation and the euthanisation of two dogs. Six mostly unregistered dogs were impounded, and investigations into potential prosecutions are underway.

The Group Manager – Planning and Regulatory noted operational challenges, including the need for additional resources, a vehicle, and more dog traps.

The committee queried:

• Whether dog control officers are equipped with body cameras. The Compliance and

Licensing Manager responded that they do not.

- The legal steps available to increase accountability of dog owners following attacks. The Compliance and Licensing Manager outlined the process of holding dog owners accountable.
- Whether the Council had made personal contact with the victims of the dog attacks. The Compliance and Licensing Manager confirmed that the Mayor had.

The District Planner reported that the TAS cabin deployments are nearing completion. Following the June floods, 22 cabins were placed across 15 properties; this has now reduced to 4 cabins on 3 properties. In two weeks, only 2 properties in Wairoa will still have cabins from the June floods, with an additional 2 properties retaining cabins from Cyclone Gabrielle.

The Committee asked about the progress of the District Plan review. The Group Manager – Planning and Regulatory advised that discussions with Ministry for the Environment (MfE) have taken place, and progress has been delayed due to ongoing Resource Management Act (RMA) reforms.

The Group Manager – Planning and Regulatory noted ongoing work to improve placard data collection following Cyclone Gabrielle, with an update due next meeting. The Senior Building Control Officer clarified that the data collected focuses on the condition of homes, whereas the Committee is seeking information on what each homeowner requires to change their placard status. The Committee suggested that the Building Department work more closely with the Recovery Department.
